Applicant Ranjit Samanta is absent without steps.

O.P. /Company is absent.

Today is fixed for passing no dispute award.

Case record is taken up for passing no dispute award.

This case has been filed by the applicant/workman Ranjit Samanta u/s 2A(2) of the Industrial Disputes Act, 1947 against his employer M/S. K.N.D. Engineering Technologies Limited in connection with termination of his service by way of refusal of employment illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that the applicant was not appearing in this Tribunal since long and as such, considering the conduct of the applicant, on 09.06.2022 order was passed to issue notice upon the applicant asking him to appear personally before this Tribunal on 26.07.2022 and file show cause as to why no dispute award shall not be passed. Thereafter, on 17.01.2023 the applicant was found absent on repeated calls inspite of notice

to file show cause was properly served upon him and the instant case was adjourned on that day and 30.03.2023 was fixed to file show cause. Since thereafter, the applicant is not appearing in this Tribunal nor has filed any show cause. The applicant did not bother to appear before this Tribunal personally or file show cause and this Tribunal holds that the applicant is not willing to proceed with his present case.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

#### Ordered

that the case being No. 32 of 2018 u/S 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
