

Ld. lawyer for the workers' union files a petition stating therein that the Secretary is unable to appear because of his illness.

None appears for the O.P/employer till 2.30 p.m.

Hd. the ld.lawyer for the workers' union, who submits that another chance be given to P.W-1 for his further examination on oath. No medical certificate is filed in support of claim of P.W-1's illness.


Perused the entire CR. Considered. It transpires from the CR that the Govt. of West Bengal through its Assistant Secretary, Labour Deptt. vide reference no. Labr.//712/(LC-IR) / IR/11L-43/17 dated 11.07.2017 referred the Industrial Disputes between the parties, as mentioned herein above, for adjudication under the Industrial Disputes Act, 1947 (hereinafter referred to as Act of 1947) for adjudication.

The Assistant Commissioner in exercise of the power conferred by U/S 10 of the Act, 1947 referred the Industrial Disputes for adjudication after framing the following issues:

1) Whether such termination of twenty workmen in the month of April, 2014, as mentioned below, by refusal of employment is justified?

2) If not, to what relief are they entitled?

After received of the aforementioned reference order this tribunal registered the instant case U/S 10 of the Act of 1947 and issued notice to the parties referred.

CR reveals that after received of the notice both the parties appeared through their engaged Ld. Lawyers and filed their statement by way of their WS. Thereafter since 19.09.2018 the matter has been fixed for evidence from the side of the workers' union but it took adjournments for more than 45 occasions on various pretext and ultimately on 06.06.2022 the Secretary filed his affidavit-inchief and he was further examined in part on oath as P.W-1.

It further transpires that thereafter the matter was fixed for further examination of P.W-1 on 13.06.2022, 07.07.2022, 03.08.2022, 02.09.2022, 14.09.2022, 13.10.2022, 07.11.2022, 25.11.2022, 13.12.2022, 09.01.2023, 03.02.2023, 28.02.2023, 15.03.2023, 27.03.2023, 31.03.2023 and this date but in all such occasions P.W-1 did not appear on taking various pretext.

Having regard to the above discussed conduct on the part of the workers' union, I am of the view that the workers' union itself is reluctant to proceed any further with this case. So, in this case, it would be appropriate to pass a 'No Dispute Award'.

Hence, it is,

Ordered

that the application under Section 10 of the Industrial Disputes Act, 1947, is dismissed for default without cost.

This is my award.
