# AWARD

Both the parties are absent without steps.

Today is fixed for passing no dispute award in view of order no. 40 dt. 28.03.2024.

Case record is taken up for passing award.

This case has been filed by the applicant/workman Saptarshi Roy under Section 10(1B)(d)of the Industrial Disputes Act, 1947 against his employer M/s. BTe-Serv (India) Private Ltd. in connection with termination of his service with effect from 27.03.2018 illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that vide order dated 23.09.2021 show cause was issued fixing 08.12.2021 for appearance and filing reply to show cause by the applicant as to why no dispute award shall not be passed in view of his non appearance before this Tribunal.

On 28.03.2024 an order was passed stating that since the notice sent to the applicant long back has not been received back by this Tribunal, hence, it can safely be presumed that the notice has been served upon the applicant. CHTH INDUSTRIAL THE BUNA On that also neither the applicant nor his Ld. Advocate was present before this Tribunal and the Ld. Advocate for the O.P. submitted that since last 2

years the applicant has not been appearing before this Tribunal and is intentionally harassing the O.P./Company and prayed to pass no dispute award in this case. However, on 28.03.2024 for ends of justice a fresh notice was issued upon the applicant asking him to appear on 17.05.2024 and to file reply to show cause as to why no dispute award shall not be passed in the instant case. Thereafter, on 17.05.2024 it appeared from the postal track report that the notice sent to the applicant has been delivered with postal remark 'Item Delivered to the Addressee'. But on the said date also none appeared for the applicant on repeated calls and the applicant did not think it necessary to appear before this Tribunal and to file reply to show cause in view of order no. 40 dated 28.03.2024. Therefore, it is clear that the applicant is not willing to proceed further with his present case/dispute.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

### Ordered

that the case being No. 02 of 2019 U/s 10(1B)(d) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
