## AWARD

Workers' Union (Registration No. 6924), 40A, Hide Road, Jain Kunj, Kolkata – 700088 Vide G. O. No. 322-IR/IR/11L-29/16 dated 11.04.2016 and reference no. 3115-IR/IR/3A-6/59, dated 21/06/1960.

The said Seventh Industrial Tribunal shall submit its award to the State Government within a period of three months from the date of receipt of this order by the said Seventh Industrial Tribunal in terms of Sub-section (2A) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947), subject to the other provision or provisions of the said Act.

The said Seventh Industrial Tribunal shall meet at such places and on such dates as it may direct.

# ISSUE(S)

- 1. Whether refusing the demands raised by the Union and subsequent declaration of suspension of work w.e.f. 29.07.2015 by the Management is justified?
- 2. To what relief, if any, are the workman entitled?

In view of G.O. No. Labr./700/(LC-IR)/23099/15/2019 dated 26.07.2019 this case has been withdrawn from the file of Seventh Industrial Tribunal and has been transferred to this Tribunal i.e. Eighth Industrial Tribunal, Kolkata for disposal.

The case record is taken up for passing order.

On scrutiny of the entire record I find that after completion of argument by the Union without hearing the argument of the Company the date for award had been fixed as the company did not turned up for a long period. On 20.07.2022 the then P.O.-in-Charge again fixed for a fresh argument by the Union and accordingly notice was issued to the Union. As the Court had

been lying vacant for three years, after joining the regular P.O. on 29.04.2024 although the Ld.

Advocate for the workman and also the workman were present but none appeared for the

Company and accordingly notices were issued to the directing to show cause and appearance of

both the parties. Thereafter from 20.05.2024 in spite of repeated issuance of show cause notices

to both the parties neither any S/R is received nor both the parties appeared before this Tribunal.

Therefore, it is crystal clear from the above conduct of the Union as well as the Company

that they are not interested to proceed with the instant case any further. In view of the aforesaid

conduct of the Union Hajra by British Electrical & Pumps (P) Ltd. Workers' Union and the

Company M/s. B.E. Pumps Pvt. Ltd., this Tribunal has no hesitation to hold that there is no

dispute exists at present between the parties and as such the case is liable to be disposed off in

view of Rule 22 of the West Bengal Industrial Dispute Rule, 1958.

Hence, it is

<u>ORDERED</u>

that the industrial dispute being No. VIII-19 of 2016 of the Industrial Disputes Act, 1947 under

reference no. 3115-IR/IR/3A-6/59, dated 21/06/1960 and also vide reference order no. 322-

IR/IR/11L-29/16 dated 11.04.2016 is no longer in-existence and accordingly the case is disposed

off and this order is to be treated as No Dispute Award between the parties.
