



Today is fixed for passing order in respect of Memorandum of Settlement on compromise dated 29.08.2024 , filed by both the parties.

The case record is taken up for passing order.

Perused the Memorandum of Settlement (Exbt. B) dated 29.08.2024, joint petition filed by the parties and petition under Section 10(1B)(d) of the Industrial Disputes Act, 1947 (as amended) as well as evidence of the applicant Sri Sudipta Kumar Dey (P.W.1) and Mr. Koustubh Pradhan, Lead - Employee Relations & Compliances , authorized representative of the Company namely M/s. Sanofi India Ltd., (O.P.W.1), the Power of Attorney enclosed (Exbt. A) , so adduced in support of said Memorandum of Settlement (Exbt. B) .It appears from the evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 29.08.2024 (Exbt. B) I further find from the said joint petition , Memorandum of Settlement as well as from the evidence of both parties that the Company has handed over a demand draft being No. 899605 dated 22.08.2024 of Rs. 6,30,402/- (Six lakh thirty thousand four hundred two) only drawn on HDFC Bank Ltd., to the applicant as full and final settlement amount and the applicant has issued a receipt of the same, marked as Exbt. B and the said demand draft was handed over to the applicant as full and final settled amount and the

applicant (P.W.1) has no grievance against the O.P./Company at present. A xerox copy of the said Demand Draft of full and final settled amount was marked as Exbt. 1. An original money receipt has been filed to that effect . Considered.

The Memorandum of Settlement dated 29.08.2024 and the joint petition dated 29.08.2024 filed by the parties has duly been signed by the applicant, Sri Sudipta Kumar Dey (P.W.1) and Mr. Koustubh Pradhan (O.P.W.1) representing the O.P./Company voluntarily. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise , which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

Hence, it is

O r d e r e d

that the settlement between the parties is allowed and accordingly, the proceedings under Section 10(1B)(d) of the Industrial Disputes Act, 1947, as amended , be and the same is disposed of in terms of the Memorandum of Settlement dated 29.08.2024. The Memorandum of Settlement dated 29.08.2024 is made part of the Award.
