### **AWARD**

This Industrial Dispute between Sri Narendra Nath Mukherjee, 2B, C. S. Mukherjee Bye Lane, South, Konnagar, Hooghly and M/s. Dewar's Garage Limited, 4, Council House Street, Kolkata-700 001 in respect of the under mentioned issues.

#### **ISSUES**

- Is the application filed by the applicant u/s. 10(1B)(d) of the I.D. Act (W.B. Amendment) maintainable in Law & Facts?
- 2) Whether the applicant is a 'workman' as contemplated u/s. 2(S) of the I.D. Act, 1947?
- 3) Whether the Domestic Enquiry proceeding initiated against the applicant were inconformity with the principles of natural justice?
- 4) Whether the dismissal of service of the applicant w.e.f. 12.2.2009 was proper & justified in Law?
- 5) Whether the applicant is entitled to get any relief as per Law & Equity?

Both the parties are present along with their Ld. Advocates and file a Memorandum of Settlement as per the provisions of Industrial Disputes Act stating the fact that the instant matter has been settled amicably in regard to the Memorandum of Settlement which they have filed before this Court today. The applicant Sri Narendra Nath Mukherjee was being examined and cross-examined by the respective Ld. Counsels appearing on behalf of the Applicant and the Company. That in his substantive evidence the applicant has stated before this Court that Memorandum of Settlement was entered into between himself and the Company voluntarily and the same had received a Cheque bearing No. 011816

dated 04.01.2022 drawn on UCO Bank, Calcutta amounting to Rs. 71,222/(Rupees Seventy One Thousand Two Hundred Twenty Two) only. The applicant has further submitted that he has no further claim against the Company and does not want to proceed in the instant matter further.

It is seen from the records that the applicant has filed an application praying for an award in terms of Memorandum of Settlement. I have carefully examined the terms of Memorandum of Settlement and also have perused the signatures of the parties in the Memorandum of Settlement. Having regards to the facts and circumstances and considering the materials on record and the terms of settlement I am of the opinion that the terms and conditions of the Memorandum of Settlement dated 10.01.2022 by and between the parties in the instant matter is legally valid and proper. I do not find any legal impediment to accept the terms and conditions of the settlement and thereby disposed of the case in between the parties.

Hence, it is

#### ORDERED

That the application filed today by the applicant is allowed in presence of the parties of this proceeding and accordingly the case is finally disposed of in terms of Memorandum of Settlement dated 10.01.2022 and such Memorandum of Settlement may made part of this award.

This is my award.

### MEMORANDUM OF SETTLEMENT

Under Section 18(3) of the Industrial Disputes Act, 1947 and Rule - 68 of the West Bengal Industrial Disputes Rule, 1958

## 4. Short Recital of the case:-

Sri Narendra Nath Mukherjee is one of the ex-Employee of the Dewar's Garage Limited. He was initially appointed as Supervisor in the year 1988 and thereafter he was promoted to the post of Manager-PDI In-Charge (Pre-Deliver Section) and he was in-charge of the Company at Sonai Road, Hide Road Extension, Kolkata-700 088. His service was terminated in the year 2006 for committing certain acts of misconduct including misappropriation of the Company's fund, taking delivery of damaged and dented vehicles from transporters against receipt of compensation without depositing the said sum to the Company's fund. Sri Narendra Nath Mukherjee filed a purported Industrial Dispute relating to his termination from service from the Company before the Learned Second Labour Court and the same has been registered as Case No. 07 of 2010. The Company was contesting the case by filing its written statement and also corroborated the said facts through its witness before the said Court. The Company challenged the maintainability of

the said case and status of Sri Narendra Nath Mukherjee. The Company also submitted that Sri Narendra Nath Mukherjee was working as Manager - PDI Incharge and his nature of duties were managerial and administrative in nature and he is not a workman u/s 2(s) of the Industrial Disputes Act, 1947. During pendency of the said purported dispute, the matter was discussed at Bi-partite level between the parties and after protracted negotiation a settlement was finally arrived at between the parties herein under the following terms and conditions. Sri Narendra Nath Mukherjee agrees to withdraw the case pending before the Ld. Second Labour Court and accepted his full and final settlement from the Company. The full and final settlement of Rs.71,222/-(Rupees Seventy One Thousand Two Hundred Twenty Two only) including of Gratuity has been duly received by Sri Narendra Nath Mukherjee and he has no remaining claim over the company.

5. Terms of the settlement:- It is agreed and settled by and between the parties;

- i) That Sri Narendra Nath Mukherjee shall have no further claim of his employment with Dewar's Garage Limited.
- That Sri Narendra Nath Mukherjee has received a sum of Rs.71,222/-(Rupees Seventy One Thousand Two Hundred Twenty Two only) vide account payee Cheque No. 011816 dated 04/01/2022 drawn in his favour on Uco Bank towards full and final settlement of all his statutory and other dues including Gratuity and he has no remaining claim over the Company whatsoever in nature.
- iii) It is agreed that after encashment of above stated amount, Sri Narendra Nath Mukherjee shall not make any claim further against the company in any manner whatsoever in nature including the claim of reinstatement in service and his retiral benefits.
- iv) It is agreed that this Memorandum of Settlement is valid subject to the encashment of the above stated account payee cheque.
