Workman is absent.

It is now 01:00 PM, on repeated calls Workman is found absent and none appears for Workman to ventilate their grievances or submission if any before this tribunal.

Ld. Counsel for the Company is present.

Record is taken up for passing appropriate order.

On perusal of the record, it is seen that on 04.04.2019 a petition was filed on behalf of the Company praying for allowing the employer to be represented through its authorised representative Sri Sankar Ghosh.

I have perused all orders being passed by this tribunal and Hon'ble High Courts and apex Courts also with due care. Since bone of contention of the appointment of Sri Amar Roy to be allowed for the employer to place their matter before this Tribunal is ended on the death of Mr. Amar Roy, I find there is no reason to go otherwise in allowing the employer to be represented through its authorised representative Sri Sankar Ghosh.

Hence it is ordered that the petition dated 04.04.2019 is allowed on ex-parte, Mr. Sankar Ghosh is allowed to represent the employer the instant case before this tribunal.



At this stage, another application has been filed on behalf of the Company praying for dismissal of the instant proceeding with cost for default on the part of the Workman / applicant as the instant matter is being regularly appeared and heard before this Tribunal, although the employer / company is regularly appearing during hearing but the workman did not appear inspite of several notices being served upon the Workman from this Tribunal and therefore, employer / company submits that this Tribunal to be pleased to dismiss the proceedings for default on the part of the workman with cost.

The petition is taken up for hearing. Heard Ld. Counsel for the representative of the employer / company.

Perused the petition and the record thoroughly.

It is fact that the workman is absent since long for a period of couple of years or more.

I find no reason to continue the proceeding further as it would be a waste of time of this Tribunal.

It is now 01:30 PM. On repeated calls none appears for the Workman. Considered the submission of Ld. Representative of the Company.

Hence, the record is taken up for order.

It is

ORDERED

that this instant case be and the same is dismissed for non-prosecution against the Workman who is not taking any step for a considerable period, with cost Rs. 500/-.
