JUDGEMENT

The case of the petitioner, in short, is that on 01.06.2014 his service was terminated by way of refusal of employment and the said termination was illegal and incorrect and for this reason he has filed this case for his reinstatement with full back wages and consequential benefits.

The O.P.-2, M/s. Smart Security Services has contested this case by filing one written statement and he has denied all the allegations of the petitioner in the written statement. This O.P.-2 has stated that the petitioner has not been appointed by this O.P.-2 and after 31.05.2014, he was absent without any notice for a considerable period and this O.P.-2 has not issued any termination letter to the petitioner and all the allegations of the petitioner are baseless and totally false.

The O.P.-2 has not filed any written statement in this case.

Thereafter, three issues have been framed by this Tribunal as follows:-

- Whether the termination of workman, Shri Amal Paul by way of refusal of employment is justified or not.
- 2. Whether the workman, in question, was terminated from service after being engaged by the company.
- 3. If not, what other relief, if any, the workman is entitled to?

The record shows that thereafter the petitioner as the PW-I has deposed in this case but his cross examination has not been completed as he did not attend this Tribunal inspite of getting sufficient opportunities and his cross examination is remaining incomplete and on 08.04.2019 he was cross examined for the last time and thereafter he did not attend for completion of his cross examination. So, the entire evidences of the PW-I are remaining incomplete.

Thereafter, the OPW-I, Sk. Rafiquddin Ahmed has deposed in this Tribunal on behalf of the O.P.-2 of this case but his evidence was expunged by order dt. 20.11.2019 passed by this Tribunal and then again this witness filed affidavit-in-chief and he was examined as the OPW-2 and he was cross examined in full on 30.12.2019 and thereafter he did not appear for cross examination by the O.P.-1 of this case and then the case was closed and fixed for hearing argument but thereafter both parties did not appear to make submission for argument inspite of getting many opportunities.

So the evidences of the petitioner (PW-1) and the OPW-2 are remaining incomplete which cannot be given any legal value and as the petitioner has filed this case, he has to prove his case by evidence but his evidence is remaining incomplete and accordingly his incomplete evidences cannot be legally considered to prove his case. Accordingly I hold that the petitioner has failed to prove this case against the O.P. and he is not entitled to get any relief in this case as prayed for.

Hence, it is

ORDERED

that the Case No. 03 of 2015 under Section 2A(2) of The Industrial Disputes Act, 1947

is dismissed on contest against the O.P.-2 and exparte against the O.P.-1 without

cost.

Let this judgement and order be treated as an Award.
