Today is fixed for passing order regarding non filing of show cause by the applicant in view of order no. 54 dt. 27.12.2021.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Smt. Aditi Mukhopadhyay U/s 10(1B)(d) of the Industrial Disputes Act, 1947 against her employer M/s. Bagaria Agencies (P) Ltd. in connection with termination of her service by way of refusal of employment illegally with a prayer to reinstate her in service with full back wages and other consequential benefits.

Perused the case record wherefrom it is seen that on 27.12.2021 case was fixed for further cross-examination of P.W.1 (Applicant), but applicant was found absent on that day on repeated calls and considering the previous conduct of the applicant, this Tribunal issued notice to the applicant directing her to appear before this Tribunal on 25.01.2022 and to submit show cause as to why no dispute award shall not be passed in the instant case. It further appears from the record that in view order dt. 27.12.2021 show cause notice under registered post with A/D was sent to the applicant and from the A/D card, so received, it appears that the said show cause notice was duly served upon the applicant on 13.01.2022 and applicant received the said notice by putting her signature with date on the A/D card, but the applicant did not think it necessary to appear before this Tribunal even also on the next date i.e. on 09.03.2022 and also did not think it necessary to file show cause in view of order no. 54 dt. 27.12.2021. Therefore, it is clear that the applicant is not willing to proceed with her present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.
