Seen the copy of Memo. No. of the notice issued upon the workman Sri Falindar Shaw under postal receipt No. RW 49805047 2IN and the postal track report received from the office. It is found that the notice issued under the postal receipt upon the workman was duly served on 21.02.2022.

The workman does not appear.

The company also failed to appear despite service of notice on 12.02.2021.

The parties did not turn up after their initial appearance as such notices were issued upon them directing them to show-cause as to why the reference should not be disposed of on the footing that there no longer existed any industrial dispute. Despite service of notice the parties did not appear.

It appears from the conduct of the parties that they are not interested to proceed with this reference which makes this Tribunal to presume that there no longer exists any industrial dispute between them.

Under the circumstances, under Rule 22 of the West Bengal Industrial Dispute Rules, 1958 the instant reference is disposed of on the footing that the industrial dispute under reference no longer exists.
