AWARD

With the Factory at 68, WBIDC Industrial Growth Centre, Gayeshpur, Kalyani, Nadia and Head Office at 166B, Shyamaprasad Mukherjee Road, Suite No. 3D, Merlin Links, Kolkata – 700036 and their workman Sri Sumanta Ranjan Pal, A-1/47, Kalyani, P.O. & P.S.-Kalyani, Nadia, Pin – 741235 relating to the under mentioned issues being a matter specified in the Third Schedule to the Industrial Disputes Act, 1947 (14 of 1947); Vide Order No. Labr./202/(LC-IR)/IR/11L-16/2018, dated 20/03/2018 & also Notification No. 3115-IR/IR/3A-6/59, dated 21/06/1960 to this Tribunal for adjudication on the following issues:-


ISSUE(S)

- 1. Whether the alleged non-payment of Bonus for the years 2012-2013, 2013-2014 & 2014-2015 (upto 14.10.2014) by the Management to the Workman Sri Sumanta Ranjan Pal is justified?
- 2. What relief, if any, is the workman entitled to?

The case record is taken up for passing order.

On perusal the case record it appears that both the parties were show caused by this Tribunal but surprisingly on the last occasion i.e. on 08/04/2022, none of the parties has appeared before this Tribunal nor filed any show cause letter. From scrutiny of the record it further reveals that in spite of several opportunities had given to the Workman Sri Sumanta Ranjan Pal, he did not come forward to contest and / or to proceed with the hearing of this case. It further reveals that several opportunities had given to the OP/Company namely M/s. Precision Engineers & Fabricators (P), Ltd. but surprisingly company also did not file the same and accordingly this Tribunal show caused the OP/Company namely M/s. Precision Engineers & Fabricators (P), Ltd. Which was also not appeared before this Tribunal on the date fixed.

Considering the above facts and circumstances, it is clear that both the parties i.e. the petitioner Sri Sumanta Ranjan Pal and OP/Company M/s. Precision Engineers & Fabricators (P), Ltd. are not insisted to proceed with the hearing of this case. Therefore this Tribunal has no hesitation to hold that there is no dispute exists at present between the parties and as such the case is liable to be disposed off in view of Rule 22 of the West Bengal Industrial Dispute Rule, 1958.



ORDERED

that Industrial Dispute under Notification No. 3115-IR/IR/3A-6/59, dated 21/06/1960 and also Vide Order No. Labr./202/(LC-IR)/IR/11L-16/2018, dated 20/03/2018, is no longer in-existence and accordingly the case is disposed off and this order is to be treated as No Dispute Award between the parties.


