Applicant Sri Ganesh Chandra Das is absent without steps.

O.P. /Company is also absent without steps.

Today is fixed for passing necessary order.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Applicant Sri Ganesh Chandra Das U/s 2A(2) of the Industrial Disputes Act, 1947 against his employer M/s.Macstar Machine Tools Pvt. Ltd. in connection with termination of his service with effect from 14.10.2012 illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it is seen that on 09.02.2022 this case was fixed for hearing argument of O.P.'s side but applicant was found absent on that day on repeated calls and considering the previous conduct of the applicant, this Tribunal issued notice to the applicant directing him to appear before this Tribunal on 28.03.2022 and to submit show cause as to why no dispute award shall not be passed in the instant case. It further appears from the record that in view order dt. 09.02.2022 show cause notice under registered post with A/D was sent to the applicant, but returned unserved with postal remark 'Left' dt. 14.02.2022. It further appears from the record that the applicant stopped taking steps on and from 23.03.2021. So, I am not inclined to issue fresh show cause notice to the applicant. The applicant did not think it necessary to appear before this Tribunal till today and also did not think it necessary to file show cause in view of order no. 77 dt. 09.02.2022. Such conduct of the applicant clearly shows that the applicant is not willing to proceed with his present case further.

SCHOOL HOUST OF A STATE OF A STAT

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

Ordered

That the case being No. 13 of 2013 U/s 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award '.
