## AWARD

Today is posted for adducing evidence by the workman. Both sides are present. The workman filed a petition praying for permitting him to withdraw the case. He is examined as C.W. No.1.

Heard both sides. Perused the oral testimony of the applicant, wherefrom, it appears that he has approached before his employer i.e.O.P.No.3, (The Proprietor, M/s. Shyama Construction, Labour Contractor of Kolaghat Thermal Power Station, Mecheda) who has assured him to settle the dispute amicably out of court and for that reason he does not want to proceed with the case. While the applicant himself does not want to proceed with the case further, the court shall not stand as bar in between the parties.



Hence, it is,

### Ordered

that the instant case filed U/s. 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non-prosecution and no industrial dispute exits in the instant case for the present.

This is the Award passed by this court and accordingly, the instant case is disposed of finally.
