## AWARD

Dated: 07-06-2018

None appears on behalf of either of the parties on repeated calls. Today is fixed for filing of written statement by the workman. No written statement has been filed.

Records reveal that on receipt of the Order of Reference No.Labr./1070/(LC-IR)/IR/11L-72/2017 dated 02.11.2017 issued on behalf of His Excellency The Governor by the Labour Department, Government of West Bengal through its Assistant Secretary, this Tribunal was called upon to adjudicate, in respect of the parties named therein, the following Issues:-

- 1. Whether the discontinuation of service of Sri Ranbir Singh w.e.f. 23.04.2016 from M/s. Stitch Fab (India) Pvt. Ltd. is due to termination of service under issued by the management of M/s. Stitch Fab (India) Pvt. Ltd. verbally or not? If so, whether the termination is justified?
  - 2. What relief, if any, is the workman entitled to?

On receipt of the said Reference, the instant case came to be registered on 22.11.2017 and accordingly notices were issued upon the parties named in the Reference with a direction upon them to appear on 28.12.2017 before this Tribunal. It further reveals that both parties appeared on the date fixed through their Ld. Advocates and thereafter the matter was fixed for filing statement of facts (W.S.) by the workman. Records further reveal that no statement of facts (W.S.) was filed on behalf of the workman on the date fixed 15.02.2018 and a prayer for adjournment was made on his behalf.

It further reveals that the matter has been fixed on three dates thereafter, however, the workman has neither appeared nor filed his statement of facts (W.S.) and accordingly, on the last date 10.05.2018 the workman was granted a final chance to file his statement of facts (W.S.). Unfortunately, once again the workman has failed to appear on the date fixed i.e. today, and further the workman has failed to comply with the direction upon him. In this context, it is relevant to note that the OP/Company has also failed to appear on the last four dates, including today.

Clearly, the conduct of the parties, by way of their unexplained absence and failure to take steps indicates that both parties have abandoned the instant case and the industrial dispute under reference is no longer in existence.

Accordingly, this Tribunal is constrained to hold that both parties to the present industrial dispute having failed to appear on multiple occasions without showing any cause and having failed to take steps on all such occasions, the instant case is a fit one to be dealt with under Rule 22 of the West Bengal Industrial Dispute Rules, 1958 and accordingly, this Tribunal further holds that the industrial dispute under reference is no longer in existence and a "No Dispute Award" be passed answering the aforesaid Reference, and disposing of the instant case registered thereupon.

The aforesaid shall **constitute the Award** passed in the instant case. The instant Case No.**VIII-25/2017**, registered on 22.11.2017, stands disposed of.
