None appears on repeated calls on behalf of either of the parties. Today is fixed for hearing of petition dated 16.03.2017 of the applicant, as final opportunity and in default, for necessary order(s).

Examined the records. Records reveal that the instant case was registered on 29.07.2016, upon an application purportedly being filed under Section 2A(2) of the Industrial Disputes Act, 1947 by the applicant Babla Das against his employer M/s. Santra Publications Pvt. Ltd., challenging the termination of his services by such employer with prayers for reinstatement with full back wages and consequential benefits. On notices being issued, the employer/company appeared through their Ld. Advocate on 07.09.2016 and filed their written statement on 05.01.2017 and thereafter on 16.03.2017, the applicant filed a petition praying for interim relief under Section 15(2)(b) of the Industrial Disputes Act, 1947. Records further reveal that the OP/Company filed written objection in respect of such prayer for interim relief on 28.08.2017 whereafter the matter came to be fixed for hearing of the said petition of the applicant.

Records further reveal that the parties have been granted several opportunities thereafter, however the petition for interim relief dated 16.03.2017 could not be heard by this Tribunal for one reason or the other over several dates, and further both the parties stopped appearing in the matter on and since 23.08.2018, on which date taking note of the conduct of the parties, this Tribunal directed that the petition dated 16.03.2017 be fixed for hearing, as final opportunity for the parties and, in default, for necessary order(s). Both the parties have not appeared on three (3) consecutive dates, including today and such conduct of the parties indicates that the industrial dispute, allegedly between them,

may not be in existence any more and this could be a fit case for proceeding under Rule 22 of the West Bengal Industrial Dispute Rules, 1958.

Accordingly, and for the reason that both parties without prior notice and/or showing sufficient cause have failed to appear before this Tribunal on consecutive dates and have further failed to act in compliance with the directions of this Tribunal on several dates, this Tribunal holds that materials on records reflect that the industrial dispute as alleged between the parties is no longer in existence and further holds that this is a fit case for passing of a No Dispute Award.

The aforesaid shall constitute the No Dispute Award passed in the instant case being No. 28/2A(2)/2016, which stands disposed of.
