AWARD

The facts of the case of the petitioner in brief are that he joined in the Opposite Party Company and was working diligently, honestly and sincerely without any black spot at Unit Bowreah Jute Mills.

It is the specific allegation that the management hurriedly and without prior permission from the Government and with ulterior motive issued Charge Sheet on 30-06-2006 against the petitioner. The petitioner replied to the charge sheet on 23-11-2006. The applicant denied the allegations leveled against him in the Charge sheet. The Enquiry Officer although held enquiry, but it was eyewash finding the workman guilty. The company without issuing second show cause notice dismissed the applicant from service illegally. The applicant raised Industrial Disputes before the Labour Commissioner, but all are in vain. The Commissioner issued a certificate. Thereafter, the applicant preferred this application praying for reinstatement of service along with back wages.



The Opposite Party entered appearance in this case and filed written objection contending inter-alia the material allegations brought by the petitioner. The Opposite Party prayed for rejection of the application.

This case was initiated on 14-05-2010. Both sides adduced evidences from their respective sides and ultimately the matter has been compromised in terms of memorandum of settlement. The parties filed their memorandum of settlement along with petition on 14-06-2019 i.e. today. The applicant is examined on recall and Mr. Pijush Kanti Biswas, the General Manager, Personnel & Administration of the company is examined as O.P.W.2.

Perused the oral testimony of P.W.1 and O.P.W.2. Heard Ld. Advocates for both the parties. It appears from hearing, oral testimony and memorandum of settlement that the matter has been compromised out of court and in terms of compromise/settlement, the company has paid a sum of Rs. 3,10,000/- (Three Lakhs Ten thousand) only, in total, by three Cheques bearing No. 000129 for Rs. 47195/- (Forty Seven thousand One hundred & Ninety Five) only, drawn on Standard Chartered Bank, N.S.Road Branch, another Cheque bearing No. 210906 for Rs. 102750/-(One Lakh Two thousand Seven hundred & Fifty) only, drawn on Union Bank, India Exchange Place, Kolkata and Cheque No. 006181 for Rs. 120,055/- (One Lakh Twenty thousand & Fifty Five) Only, drawn on H.D.F.C Bank, Sarat Bose Road Branch, and Rs 40,000/-(Forty thousand) only, in cash totaling Rs. 3,10,000/- (Three Lakhs ten thousand) only, to the applicant and the applicant has received the same, The applicant has also deposed that he has no further claim. He received the above Cheques and hard cash towards full and final settlement.

On further perusal of the memorandum of settlement, it appears to this court that the terms and conditions are legal, valid and sufficient.



Accordingly, this case is disposed of in terms of memorandum of settlement.

Hence, it is

Ordered

that the instant petition U/s. 10 (1B)(d) of Industrial Disputes Act, 1947 is here by disposed of in terms of memorandum of settlement. The memorandum of settlement be made part of the Award.

This is the Award passed by this court.
