Today is fixed for filing show-cause by the applicant.

Applicant is absent without steps and does not appear even on repeated calls. It is 11:50 a.m. now.

The Company also failed to file additional written statement despite affording a number of opportunities.

The applicant / workman filed the instant application u/s. 10(1B)(d) of the Industrial Disputes Act, 1947 after obtaining certificate from the Conciliation Officer praying for his reinstatement with due wages on the ground that he was illegally terminated from service by the Company. After framing of issues the case was fixed for recording evidence. At this stage, the applicant amended his written statement. The Company was given opportunity to file additional written statement, but the record reveals that the parties did not turn up on and from 16.12.2019.

It appears from the conduct of the workman that he is not interested to proceed with his application.

Having regard to the facts and circumstances and the conduct of the parties it can fairly be presumed that the dispute between the parties no longer exists. Therefore, the instant application u/s. 10(1B)(d) of the Industrial Disputes Act, 1947 stands dismissed under Rule 22 of the West Bengal Industrial Dispute Rules, 1958 and an award in this case is passed accordingly.
