Parties take no steps. On calls neither the workman nor the company nor any of their Ld. Advocates appears. It is 1:30 p.m. now. No cause is shown by the applicant as directed.

Perused the case record.

The instant application under Section 10(1B)(d) of the Industrial Disputes Act, 1947 was filed by the applicant challenging that his termination of service is unlawful and prayed for the relief of his reinstatement with his due wages on and from 19.06.2016. The company had been contesting the application by filing their written statement.

After framing of issues on 13.02.2019 the case was fixed for hearing on merits on 19.03.2019. Despite availing a number of opportunities the applicant failed to adduce evidence till this day.

Considering the facts and circumstances and the conduct of the applicant it appears that he is leastly interested to proceed with the case and therefore it can fairly be presumed that no industrial dispute between the parties exists any longer. Dragging the case further aimlessly will only add to the age of the case.

Since no industrial dispute exists any longer between the parties, the instant application under Section 10(1B)(d) of the Industrial Disputes Act, 1947 is disposed of as no dispute in accordance with Rule 22 of the West Bengal Industrial Dispute Rules, 1958.
