AWARD

The instant case No.08/2A(2) / 2018 came to be registered upon filing of an application dated 21.02.2018 by the workman Sri Shyamal Bhattacharjee under Section 2A(2) of the Industrial Disputes Act, 1947 (together with letter of authority and service copies of the application), wherein the said Sri Shyamal Bhattacharjee claimed to be a workman and raised an industrial dispute against his employer M/s. Alakendu Bodh Niketan Residential (ABNR) with its Head Office at P-1/4/1, C.I.T. Scheme, VII-M, VIP Road, Kankurgachi, Kolkata - 700 054, alleging wrongful and illegal termination of service by the said employer and seeking reinstatement in service with full back wages and consequential benefits. Upon registration of the instant case, notice was issued upon the O.P./Company, directing them to appear on 20.03.2018 and file their written statement. The O.P./Company duly appeared on the date fixed through their Ld. Advocate and prayed for time to file their written statement. However, before such written statement as well as list of documents could be filed by the parties, they entered into a mutual settlement. Accordingly, they have filed a joint-petition along with a Memorandum of Settlement, with a prayer for passing an Award in terms of the settlement. The concerned workman Sri Shyamal Bhattacharjee and Sri Pranab Kumar Raychaudhuri, the authorized representative/signatory of the O.P./Company M/s. Alakendu Bodh Niketan Residential (ABNR) have deposed in support of their joint-petition of compromise and the terms of the Memorandum of Settlement.



In terms of the settlement, the workman Sri Shayamal Bhattacharjee has received 2 (two) cheques being No.327332 dated 08.06.2018 drawn on Account No.0956000100027158 of value Rs.2,10,000/- (Rupees Two Lakhs Ten Thousand only) & No. 067026 dated 08.06.2018 drawn on Account No. 0956000100027167 of value Rs.10,000/- (Rupees Ten Thousand only), both accounts held in the Maniktala Branch (0956) of Punjab National Bank, from the company representative. Upon receipt of such cheques, Shri Debasis Mondal has issued a receipt thereof in writing, which may be kept with the records. Further copies of the cheques duly countersigned by the authorized representative of the O.P./Company have also been filed and may be kept with the records.

Having examined the Memorandum of Settlement and the joint petition for compromise, as well as the evidence adduced by the parties, this Tribunal finds no impediment in allowing the prayers, made jointly by the parties, for passing of an Award, in terms of the Memorandum of Settlement duly executed by and between the parties.

Let the instant case be disposed of in terms of Memorandum of Settlement in between the parties filed this day, which do form part of the Award.

The aforesaid shall constitute the Award passed in the instant case.
