### A W A R D

The CR is taken up for passing order regarding the workman's petition dated 18.01.2023 whereby he prays for dropping the instant proceeding on the ground that the O.P establishment has already been referred to the infolvency proceeding.

During the course of hearing it was submitted by the ld. lawyer or the workman that from the copy of notice published in prescribed Form 4. the workman came to know that the O.P concerned M/S Jyoti Structures 1. has already been submitted to insolvency proceeding on and from ()4.07.27 and accordingly the workman's petition U/S 10(11)(d) of the I.D.Act, be dropped.

Perused the entire CR as well as copy of the notification. Considered

CR reveals that the instant case has been initiated on the basis and application U/S 10(1B)(d) of the I.D.Act, 1947 filed by the workman Kumar Mahapatra praying for adjudication of the Industrial Disputes between him and his employer i.e. M/S Jyoti Structures Lie.

It further reveals from the workman petition hat he made a representation on 17.08.2016 with the Assistant Labour Commissioner rating proceeding could not be completed till 22.07.2022 he obtained prescribed thereafter filed this case.

CR further reveals that after filing of the impugned petition this tribunal registered the instant case under the I.D. Act, 1947 and issued notice upon the O.P/employer on both the addresses, as mentioned by the workman in his

impugned petition and that the notice to the O.P's address situated at Purulia returned unserved with the postal remark "Addressee cannot to be located". After received of the same this tribunal directed the workman to furnish better particulars of his employer's address for issuance of notice afresh upon it. But the workman failed to provide the same and ultimately on 18.01.2023 filed the instant petition alongwith the copy of the published notice.

From the copy of the public announcement published in Form A under Regulations VI of the Insolvency and Bankruptcy Board of India (Insolvency Resolutions and Process for corporate persons) Regulations, 2016 it is evident that the same was published for inviting claims of the financial creditors of the employer M/S Jyoti Structures Ltd. including workmen/employees. It further directed the workmen/employees to submit their proofs of claim by electronic means with the authority i.e Interim Resolutions Professional within 26.07.2017.

In view of above facts and circumstances it is crystal clear that the O.P establishment, which is a corporate body was/is under the insolvency process under the Hon'ble National Company Law Tribunal, Mumbai Bench/appropriate authority at the time of filing of the instant petition U/S 10(1B)(d) of the I.D.Act, 1947 by the above named workman.

That apart, in terms of the Sec. 14 of the IBC the Board has also passed the moratorium of prohibiting all types of suits, recovery, actions against corporate debtor i.e.O.P with effect from 04.07.2017 till completion of the insolvency process.

Having regard to the above facts and circumstances as well as the fact the workman does not want to proceed further with the instant case, this tribunal is of the view that there exists no Industrial disputes between the above-named workman and M/S Jyoti Structures Ltd.

Hence, it is,

# Ordered

that the application under Section 10(1B)(d) of the Industrial Disputes Act. 1947. is dismissed for non prosecution but without cost.

This is my award.
