Hooghly, Pin Code-712221 , and their workman Sri Akbar Ali, S/O.Late Mukhtar Hussain, Angus Cooli Line Qtr. No. 78/15, Residing at P.S. Bhadreswar P.O. Angus, Champdani, Dist. Hooghly, Pin Code-712221, regarding the issues being a matter specified in the Second schedule of the Industrial Dispute act, 1947 (14of 1947);

AND WHEREAS the workman has filed an application directly under sub-section 2 of Section 2A of the Industrial Dispute act, 1947 (14of 1947) to the Judge, Third Industrial Tribunal Specified for this purpose under this Department Notification No. 101-IR dated 2.2.12;

AND WHEREAS the Judge of the said Third Industrial Tribunal heard the Parties and framed the following issues as the "Issue" of the said dispute;

Parties take no steps.

No cause is shown by the applicant as directed.

The applicant filed the instant application under Section 2A(2) of the Industrial Disputes Act, 1947 challenging the termination of his service by the OP/Company.

The OP/Company have been contesting the case by filing written statement.

After framing of issues the case was posted for evidence by the applicant on 16.10.2019, but till date the applicant did not adduce evidence. The applicant also failed to show-cause as directed.

Having regard to the facts and circumstances and the conduct of the applicant it appears that he is hardly interested to proceed with this case and it can reasonably be presumed that the industrial dispute between the parties no longer exists. The Tribunal cannot wait for the appearance of the applicant for an indefinite period.

Therefore, the application under Section 2A(2) of the Industrial Disputes Act, 1947 is disposed of on the footing that the industrial dispute is no longer in existence under Rule 22 of the West Bengal Industrial Dispute Rules, 1958.
