Applicant Mukesh Patra is present with his Ld. Advocate.

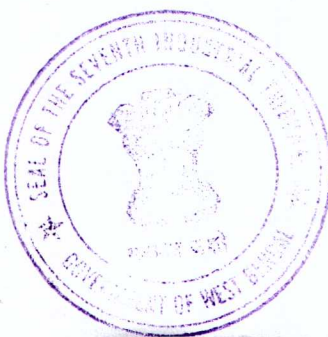
Today is fixed for appearance of O.P./Company and filing written statement.

Heard Ld. Advocate for the applicant as well as applicant Mukesh Patra in person, who submits that due to change of the address of the O.P./Company from Kolkata to Howrah, the territorial jurisdiction of the instant case falls under the jurisdiction of 2nd Industrial Tribunal, Kolkata and so, the instant case is required to be withdrawn and filed before the 2nd Industrial Tribunal, Kolkata and so, he prays for permission to withdraw the instant case against the O.P./Company. He further submits that he has voluntarily filed the present withdrawal petition and also voluntarily puts his signature thereon.

Perused the present petition for withdrawal along with case record. This is a case U/S 2A(2) of Industrial Disputes Act, 1947, filed by the applicant Mukesh Patra against O.P./M/s. The Himalaya Drug Company. 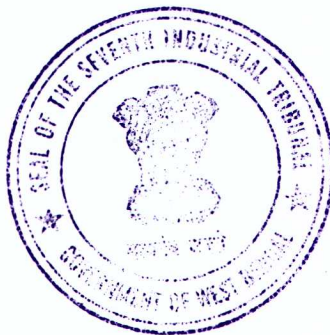
The instant proceedings stands disposed of as withdrawn.
