AWARD

The instant case arose out of an order of reference no. 22-I.R./IR.11L-105/2007, dated 07.01.2008 by which an industrial dispute between M/s. Ramakrishna Mission Institute of Culture, Gol Park. Kolkata-700 029 and their workman Sri Ram Narayan Mishra, 30E, Gariahat Road, Kolkata-700 029 as referred by the Labour Department. Govt. of West Bengal to this tribunal for adjudication.

The issues specified in the order of reference are as follows:

<u>ISSUE(S)</u>

- 1. Whether the termination of service of Sri Ram Narayan Mishra by the management of M/s. Ramakrishna Mission Institute of Culture from 14.09.2006 is justified?
- 2. What relief, if any, is he entitled to?

On receipt of the aforesaid reference issued by the Labour Department, Govt. of West Bengal, this tribunal registered the aforesaid case vide order no. 1, dated 22.01.2008. Thereafter, notices were issued to the parties asking them to appear and to file written statement. The parties did not turn up in spite of service of notices. Consequently, a 'No dispute' award was passed on 11.03.2008. Thereafter, the workman filed an application for restoration of reference after setting aside the said 'No dispute' award. After hearing both sides the said application was dismissed by this tribunal vide order no. 9 dated 28.11.2008. Thereafter, the workman moved the Hon'ble High Court in WP no. 110 (w) of 2009. But Hon'ble High Court vide order dated 20.01.2012 was pleased to set aside the order dated 11.03.2008 and 28.11.2008 passed by this tribunal and the said WP was disposed accordingly. Thereafter both parties appeared and application was filed by the workman in terms of the said order passed by the Hon'ble High Court and thereby allowing him to contest the case. During the pendency of the said application the parties expressed their desire to have the dispute mentioned in the order of reference settled amicably. Accordingly, they sought for time to explore the possibility of settlement.

Today a joint petition is filed by the parties together with Memorandum of Settlement praying for passing an order/award in terms of said Memorandum of Settlement.

Statement of the workman Ram Narayan Mishra and Swami Tattwatitananda for the company is recorded on S/A. Perused the letter of authority issued by Swami Suparnananda, Secretary of Ramakrishna Mission Institute of Culture, Golpark, authorising said Swami Tattwatitananda to adduce evidence on behalf of the opposite party, namely, said Mission. The workman has stated that the disputes involve in the instant proceedings has been settled by and between him and the employer namely, the opposite party, Ramakrishna Mission Institute of Culture. He has stated that such settlement has been made them at their own accord and nobody induced him to enter into such settlement. He has further stated that in terms of such settlement the employer Ramakrishna Mission Institute of Culture issued to him an Account Payee Cheque No. 147000 dated 15.05.2018 drawn on United Bank of India, Golpark branch in his name. He has further stated that the contents of the Memorandum of Settlement and the Joint petition of compromise was read over and explain to him in Hindi and having satisfied, he signed the same voluntarily in presence of Ld. Advocate on record of the parties. He has prayed for passing necessary award in terms of settlement.

The statement Swami Tattwatitananda is recorded on S/A. He has also stated that the disputes involve in the present proceedings have been settled amicably by the workman and the management. He has also stated that a joint petition together with Memorandum of Settlement have been filed for passing necessary award in terms of such settlement. He has signed the same for the employer being duly authorised. He has produced the letter of authority. The witness has also stated about handing over one Account Payee Cheque in the name of the workman in terms of such settlement.

Decision with Reasons

Considered the aforesaid statement of the witnesses. Considered also the joint petition filed by the parties which are duly signed their Ld. Advocates. Perused also the Memorandum of Settlement in the form of affidavit signed by the parties. Perused the money receipt signed by the workman regarding receipt of Rs. 3 lakhs through an Account Payee Cheque handed over to him by the opposite party namely the Ramakrishna Mission Institute of Culture, Golpark, seen also the xerox copy of said cheque. Heard the Ld. Advocate of both parties. The term of settlement appears to be valid and illegal. The parties have categorically stated that they signed the joint petition of compromise and the Memorandum of Settlement voluntarily. That being so, I find no legal impediment to accept the said Memorandum of Settlement. Consequently, the joint petition filed by the parties to settle the dispute in terms of the Memorandum of Settlement is allowed. Accordingly, I hold that an award should be passed as prayed for by the parties in terms of said joint petition of compromise and Memorandum of Settlement.



Hence, it is

ORDERED

let an award be passed in terms of the Memorandum of Settlement dated 16.05.2018 duly signed by the parties. Let the said Memorandum of Settlement be made as a part of the award along with annexure, if any. The instant case is thus disposed of accordingly.

This is my <u>AWARD</u>.
