

This Industrial Dispute between M/s. GATI MOTORS PVT. LTD, Bonagram Gopalmath, G. T. Road, Durgapur - 713217 and its workman Shri Sourav Mukherjee, Dakshinayan, Dharmaraj Path near Kali Mandir, P.O.-Nadiha, Durgapur - 713201 has been referred by the Labour Department, I. R. Branch, Writers' Buildings, Kolkata - 700001, to the 5th Industrial Tribunal Vide No.274-I.R./IR/11L-33/15, dated Kolkata, the 20th March, 2015 under Notification No.803-IR/IR/3A-2/57, dated 11/03/1957, for adjudication upon the under-mentioned following issues. Thereafter, the case record again transferred before this Tribunal Vide G. O. No. Labr./274-I.R./IR-11L-33/15, dated 20/03/2015 for the purpose of adjudication.

ISSUES

- (1) Whether the dismissal from the service of Sri Sourav Mukherjee w.e.f. 20/03/2015 by the management of M/s. Gati Motors Pvt. Ltd. is justified?
- (2) To what relief, if any, the workman is entitled?

Originally the case record was fixed today for argument. At this stage both the parities filed a joint petition and submitted that both the parties have agreed among themselves to settle the disputes and to that effect they also filed a memorandum of settlement before this Tribunal supplied by verification and also filed two affidavit-in chief of both the parties along with necessary documents and also prayed for disposed of the case as per terms and conditions of the Memorandum of Settlement. Both the parties are present along with their Ld. Advocates and Ld. Advocate for M/s. Gati Motors Pvt. Ltd. submitted that he has no objection if the instant case is disposed of on the basis of the terms and conditions of the Memorandum of Settlement.




Both the Ld. Advocates of the parties jointly submitted that the dispute between the parties in the present case has been amicably settled out of Court / Tribunal and to that effect a memorandum of settlement dated 06/01/2023 has prepared by both the parties and the parties also finalized their disputes in terms of the memorandum of the settlement. In view of the above facts and circumstances both the parties prayed for disposal of the case in terms of memorandum of settlement dated 06/01/2023.

In support of their contention the workman Shri Sourav Mukherjee examined himself as PW-1, who is the workman of M/s. Gati Motors Pvt. Ltd. and the memorandum of settlement is marked as Exhibit-1 and the photocopies of his Aadhaar Card are marked as Exhibit-2 respectively. He also admitted and agreed with the terms and condition of the Memorandum of Settlement and prays for disposal of the case in view of the Terms and Conditions of the Memorandum of settlement and his cross examination is declined by the Ld. Advocate of M/s. Gati Motors Pvt. Ltd.

On the contrary one the General Manager of Gati Motors Pvt. Ltd. examined himself as OPW-1 and the photocopy of Authorization Letter dated 05/01/2023 of M/s. Gati Motors Pvt. Ltd. is marked as Exhibit-A and the photocopy of Aadhaar Card of OPW-1 is marked as Exhibit-B and the photocopy of money receipt dated 06/01/2023 is marked as Exhibit-C and he has categorically stated about the settlement by and between the parties and he also stated that the management of Gati Motors Pvt. Ltd. has no objection if the present case is disposed off as per terms and conditions of the settlement petition and practically the management of Gati Motors Pvt. Ltd. also prays for disposed of the case on the basis of the terms and condition of the settlement petition.

This Tribunal has carefully examined the terms and condition of the memorandum of settlement and also has scrutinized the signatures appeared in the memorandum of settlement by both the parties.



It reveals that the management of M/s. Gati Motors Pvt. Ltd. duly authorized Vide resolution dated 11/12/2022 to empower to Sri Hari Sadhan Rakshit sign and to execute the terms of settlement between the parties and accordingly Sri Hari Sadhan Rakshit put his signatures upon the same. It further reveals that the management has paid Rs. 3,00,000/- (Rupees Three Lakhs) only to the petitioner Shri Sourav Mukherjee through Bank Draft of State Bank of India, Com. Branch, Durgapur and also paid Rs. 10,000/- by cash in presence of his Ld. Advocate which has been admitted by the petitioner Sri Sourav Mukherjee.

Having regard to the facts and circumstances and considering the materials on records and the terms of the settlement, this Tribunal is of the opinion that the terms and conditions of the settlement dated 06/01/2023 by and between the parties of this case are legally valid and proper.

There is no legal impediment to accept the terms and condition of the settlement and to dispose of the case between the parties.

Hence,

ORDERED

that the application dated 06/01/2023, filed by both the parties are allowed in presence of both the parties of this proceeding along with their advocates. Accordingly the instant case is finally disposed off in terms of the memorandum of settlement dated 06/01/2023 and the said memorandum of settlement be made part of this award.

This is the Award of this Tribunal.



That the applicant was the sales officer w.e.f. 01.03.2008 in the establishment of Opposite Party with a salary of Rs.3500/- per month and was continuing his service till January, 2011. That the applicant as usual went to the establishment on regular basis from 01.02.2011 to 25.07.2011 for performing his duty but was not allowed to join by the then Sales Manager, who refused to allow him to perform his job without showing any cause and/or holding domestic enquiry as per the provision of I.D. Act, 1947. This is denied by Gati Motors Pvt Ltd. On 25.07.2011, the applicant made representation to the Managing Director of the company but all were in vein. The workman raised dispute before the Deputy Labour Commissioner West Bengal Durgapur but the conciliation

could not be settled and the failure report was sent to the Labour Department, Government of West Bengal who referred the matter before this Learned Tribunal.

5. Terms of settlement:
