WHEREAS an industrial dispute existed between M/s. Raj Kamal Water Meter Mfg. Co. Howrah Industrial Estate Shed No. Z-8 and Z-9 Balitikuri Das Nagar, Howrah, Pin - 711113 and Sri Munna Sinha, S/o. Nandalal Sinha, Kona Purba Para Pilot Bagan, P.O. Kona, P.S. Liluah, Distt. Howrah, Pin - 711114 regarding the issue, being a matter specified in the Second schedule to the Industrial Dispute Act, 1947 (14 of 1947);

AND WHEREAS the workman has filed an application under section 10(1B) (d) of the Industrial Dispute Act, 1947 (14 of 1947) to the Second Industrial Tribunal specified for this purpose under this Deptt.'s Notification No. 1085-IR/12L-9/95 dated 25.07.1997.

AND WHEREAS, the Second Industrial Tribunal heard the parties under section 10(1b) (d) of the I.D. Act, 1947 (14 of 1947) and framed the following issue dismissal of the workman as the "issue" of the dispute.

AND WHEREAS the Second Industrial Tribunal has submitted to the State Government its Award dated 29/07/2022 under section 10(1B) (d) of the I.D. Act, 1947 (14 of 1947) on the said Industrial Dispute vide memo no. 1195 - L. T. dated 29/07/2022.


