Applicant Smt. Suchitra Saha is absent without steps.

O.P. /Company is also absent without steps.

Today is fixed for passing no dispute order in view of order no. 25 dt. 14.09.2021.

Case record is taken up for passing order.

This case has been filed by the applicant/workman **Smt. Suchitra Saha** U/s 2A(2) of the Industrial Disputes Act, 1947 against her employer M/s. M.P. Estate Handloom Waiver Cooperative Federation Society Limited in connection with termination of her service with effect from 31.07.2017 illegally with a prayer to reinstate her in service with full back wages and other consequential benefits.

Perused the case record wherefrom it is seen that on 14.09.2021this case was fixed for evidence of applicant's side, but on that day applicant was absent. Ld. Advocate for the applicant submitted that the applicant stopped making any contact with him and considering such submission, this Tribunal issued notice upon the applicant directing her to submit show cause on 22.11.2021 as to why 'No Dispute Award' shall not be passed in the instant case. It appears from the record that in view order dt. 14.09.2021 show cause notice under registered post



with A/D was sent to the applicant. It further appears from the record that till 20.05.2022 no S/R of notice (A/D card) was received and since long time had already been lapsed, this Tribunal presumed vide order dt. 20.05.2022 that show cause notice had duly been served upon the applicant and so, need issue fresh show cause notice or to wait for S/R of notice (A/D Card) unnecessarily and fixed 24.06.2022 for passing No Dispute Award. On 24.06.2022 and thereafter on 19.07.2022, this Tribunal was on leave and so, order could not be passed. The applicant did not think it necessary to appear before this Tribunal till today and also did not think it necessary to file show cause in view of order no. 25 dt. 14.09.2021. Therefore, it is clear that the applicant is not willing to proceed with her present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

Ordered

That the case being No. 26 of 2018 U/s 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
