AWARD

This Award is delivered on Thursday, the 30th day of October, 2025.

The case record is taken up for passing award in terms of the Memorandum of Settlement.

Perused the Memorandum of Settlement dated 24.09.2025 (Exbt. 1), joint petition filed by the parties as well as evidence of the applicant Jeetendra Jha @ Jitendra Jha (P.W.1) and Mr. Vishal Shukla (O.P.W.1), one of the Directors of the O.P./Company namely M/s Affairs Exhibition & Media (P) Ltd., so adduced in support of said Memorandum of Settlement (Exbt.1).

It appears from the evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 24.09.2025 (Exbt. 1) . I further find from the said joint petition, Memorandum of Settlement as well as from the evidence of both parties that the O.P./Company has handed over a demand draft being No. 024199 dated 24.09.2025 of Rs. 2,50,000/- (Two lakh fifty thousand) only drawn on HDFC Bank to the applicant as full and final settlement amount and also that the applicant (P.W.1) has no grievance against the O.P./Company at present. The xerox copy of the said demand draft as full and final settlement amount has been marked as Exbt.2. The receipt issued by the applicant as to receiving of demand draft ,marked as Exbt. A.

Considered.

The Memorandum of Settlement dated 24.09.2025 and the joint petition dated 24.09.2025 filed by both the parties has duly been signed by the applicant, Jeetendra Jha @ Jitendra Jha (P.W.1) and Mr. Vishal Shukla (O.P.W.1) representing the O.P./Company voluntarily. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

Hence, it is

Ordered

that the settlement between the parties is allowed and accordingly, the proceedings of the instant case being No. 06/2015 under Section 2A(2) of the Industrial Disputes Act, 1947, as amended, be and the same is disposed of in terms of the Memorandum of Settlement dated 24.09.2025. The Memorandum of Settlement dated 24.09.2025 is made part of the Award.
