This purported industrial dispute existing between M/s Mahindra & Mahindra Financial Services Limited, 9th Floor, Eco – Centre, Plot – 04, Block – EM, Sector – V, Bidhannagar, Kolkata - 700091 and its workman Smt. Sumitra Maiti, Jadavpur, Garfa, Senpara, Kolkata - 700075 emanates out of an order of reference vide G.O. No. Labr/761/(LC-IR)/22015(17)/1/2018 dated 04.07.2025 in exercise of the power conferred by Section 10 read with Section 2A of the Industrial Disputes Act, 1947 (14 of 1947) which has been sent to this Tribunal for adjudication on the following issues:-

ISSUE(S)

- 1. Whether the termination of services of Smt. Sumitra Maiti w.e.f. 06.03.2021 by the management of M/s. Mahindra & Mahindra Financial Services Limited is justified?
- 2. What relief, if any, the workman is entitled to?

Today is the date fixed for filing Written Statement by the OP/Company and S/R appearance of the applicant.

None appears on behalf of the OP/Company on repeated outside calls.

It is now 12:30 PM.

One report from the Garfa Police Station with regard to serve the Notice upon the applicant Smt. Sumitra Maity, is received. In which the one Constable of Garfa Police Station has stated that the attached summon could not be served as the address of the addressee could not be fixed up. This report is duly forwarded by Officer-in-Charge of Garfa Police Station.

It is pertinent to mention that this case is initiated on 09.07.2025 on the basis of Order of Reference vide G. O. No. Labr/761/(LC-IR)/22015(17)/1/2018 dated 04.07.2025 of the Government of West Bengal. In a reference order, it is revealed that the copy of this reference order was duly intimated to OP M/s Mahindra & Mahindra Finance Limited and to the applicant mentioning Smt. Sumitra Maity, Jadavpur, Garfa, Senpara, Kolkata – 700 075 along with other competent officers.

Accordingly, from this Tribunal Notice was issued upon the applicant on such above address as well upon the OP/Company through Speed Post.

OP/Company after receiving such Notice on 14.08.2025 appeared before this Court by filing Vakalatnama but Notice upon the applicant was received on 14.08.2025 with a Postal remark "in sufficient address".

Then, on 19.08.2025 again Notice upon the applicant was sent through Speed Post by fixing next date 04.09.2025. Again on 04.09.2025 the Notice was received unserved with a Postal remark "in-sufficient address" by the postal staff dated 26.08.2025.

Then, to ensure the appearance of the applicant, the Notice was served through I.C., Jadavpur Police Station by fixing the date on 04.09.2025. That Notice was received unserved with a report from the O.C. Jadavpur, with a report that after enquiry, it came to know that the jurisdiction of the applicant lies in the Garfa Police Station.

Accordingly, the Notice was again served through Garfa Police Station by fixing the date on 01.12.2025 i.e. today.

Today the report of the Garfa Police Station shows that no such address of applicant is traced out within their jurisdiction. Resultantly the Notice is received 'unserved'.

In the above circumstances, the Tribunal is having no option but to pass "No Dispute Award'.

As such,

it is ordered that no industrial dispute is in existence between the parties and accordingly 'No Dispute Award' is passed.
