Today is fixed for passing order in respect of the joint petition for compromise dated 25.03.2022 filed by both the parties.

The case record is taken up for passing order.

Perused the joint compromise petition, Memorandum of Settlement, both dated 25.03.2022 . petition U/s 2A (2) of the Industrial Disputes Act, 1947 (as amended) as well as evidence of the applicant Shri Brindaban Das (P.W.1) and Shri Jiban Kumar Banerjee (O.P.W.1), authorized representative of the Company and also one of the partners of the Jaybeeco Company, so adduced in support of said compromise petition and also Exbt. F (authorization letter dated 25.03.2022) and Exbt. G , money receipt of Rs. 10,000/- dated 03.03.2023.

It appears from the evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 25.03.2022, as mentioned in the compromise petition dated 25.03.2022. I further find from the said Memorandum of Settlement as well as from the evidence of both parties that the company handed over a cash of Rs. 10,000/- (Ten thousand) only to the applicant as settled amount, original money receipt dated 03.03.2023 of the said cash amount has also been filed with the compromise petition and the applicant (P.W.1) has no grievance against the O.P./Company at present. The joint compromise petition and Memorandum of Settlement both dated 25.03.2022 have duly been signed by the applicant, Shri Brindaban Das (P.W.1) and Shri Jiban Kumar Banerjee (O.P.W.1), on behalf of the O.P./Company voluntarily. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise, which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer, made jointly by the parties voluntarily.

Hence, it is

Ordered

That the joint compromise petition dated 25.03.2022 is allowed and accordingly, the proceedings under Section 2A(2) of the Industrial Disputes Act, 1947, as amended, be and the same is disposed of in terms of the Memorandum of Settlement dated 25.03.2022. The joint petition of compromise and Memorandum of Settlement, both dated 25.03.2022, be made part of the Award.

5. TERMS OF SETTLEMENT:

That the parties intended to settle the matter to avoid continuity of litigations and came to a settlement which terms and conditions is as follows:

- A. That the opposite party will pay Rs. 10,000/- in cash to the applicant as settlement amount without prejudice to its rights and contentions to rely the statement made in its written statement.
- B. That the applicant will receive the said amount i.e. Rs. 10,000/ in cash as his full and final settlement amount without pursuing his prayer made in his written statement before this Ld. Tribunal.
- C. The applicant undertakes that after getting the said settled amount he will not claim any further money or employment whatsoever from the opposite party in future and all his claim is being settled by this settlement.
- D. Both the parties being satisfied with the terms and conditions of the agreement have put their respective signature over the same at their own wish.
- E. The parties of the dispute further agreed that they will approach the Ld. Tribunal to pass appropriate award in terms of this memorandum of settlement on the next date i.e. 03.03.2021. 25.3.2022
