Applicant Sri Rajesh Kumar Pandey is absent without steps.

Today is fixed for passing no dispute award in view of order no. 26 dt.

01.10.2021.

This case has been filed by the applicant/workman Sri Rajesh Kumar Pandey U/s 2A(2)) of the Industrial Disputes Act, 1947 against Opposites Parties viz. 1. Bagree Estates Pvt. Ltd., 2. Smt. Radha Bagree, Director, Bagree Estates Pvt. Ltd, 3. Varun Raj Bagree, Director, Bagree Estates Pvt. Ltd, & 4. The Executive officer, Bagree Estates Pvt. Ltd in connection with termination of his service through letter dt. 08.11.2017 by the Executive Officer of the Bagree Estates Pvt. Ltd. illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it is seen that on 01.10.2021 this case was fixed for ex parte hearing, but applicant was found absent on that day on repeated calls. Considering such conduct of the applicant, this Tribunal issued notice under registered post with A/D directing the applicant to show cause as to why no dispute award shall not be passed, but S/R of notice was returned unserved. Since the applicant stopped taking steps on and from 01.10.2021 and also did not think it necessary to appear before this Tribunal till 21.04.2022, this Tribunal need not issue fresh show cause notice to the applicant in view of order no. 26 dt. 01.10.2021. Even applicant did not think it necessary

to appear before this Tribunal or to file show cause petition till today. Therefore, it can safely be said that the applicant is not willing to proceed with his present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

### Ordered

That the case being No. 4 of 2018 U/s 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
