Today is fixed for passing order.

By a petition dt. 10.12.2019 the O.P. company prayed for passing order as the present case is not maintainable U/s. 2A(2) of the Industrial Disputes Act, 1947.

Heard both sides. The Ld. Lawyer for the O.P. Company submits that he will not move this petition. Hence this petition is rejected as not moved by the O.P. Company.

The petition dt. 02.01.2020 filed by the petitioner is taken up for hearing.

Heard both sides and perused the record.

As per this petition, the petitioner has prayed for withdrawal of this case with a liberty to file a fresh case in terms of the existing law because Section 2A(2) of the Industrial Disputes Act, 1947 has been repealed and accordingly if this case is not withdrawn, the petitioner will suffer loss and injury.

Considering the present position of law, the prayer of the petitioner for withdrawal of this case is allowed.

Hence it is

Ordered,

that the case No. 01/2018 is withdrawn with liberty to the petitioner to file a fresh case in terms of the existing law.
