On repeated calls, neither the parties nor their ld. advocates appear.

Postal A.D. card of notice issued upon the workman is received after service.

The reference was received by this Tribunal from the Government to adjudicate the issues enumerated therein.

On receiving initial notice the company appeared, but they did not file their written statement. Despite sending repeated notices, the union namely Kapila Dairy & Industries Workers' Union did not turn up. The workman namely Samir Majhi also did not appear despite service of notice upon him. The company has also stopped appearing. The reference received by this Tribunal on 03.02.2021 but till date neither the union nor the workman appeared despite service of notice.

Considering the facts and circumstances, nature of the case as well as the conduct of the parties it appears that none of the parties is interested to proceed with the case leading this Tribunal to presume that the dispute between the parties no longer exists.

Therefore, the instant reference is disposed of under Rule 22 of the West Bengal Industrial Dispute Rules, 1958 on the footing that there no longer exists any industrial dispute.
