

The O.P. company has filed written statement along with the copies. Let it be kept with the record.

The petitioner is absent and the Ld. Lawyer for the petitioner is also absent and no step is taken for the petitioner. On perusing the record I find that on the last two occasions also the petitioner did not appear.

So considering the conduct of the petitioner, I hold that the petitioner is not interested to proceed with this case further and he is absent for the last three days without any explanation.

On perusing the record I find that the petitioner has filed this case under Section 10(1B)(d) of The Industrial Disputes Act, 1947 against the O.P. company but considering the above mentioned conduct of the petitioner, I hold that the petitioner is

not interested to proceed with this case.

Hence, it is

ORDERED

that the Case No. 22 of 2022 under Section 10(1B)(d) of The Industrial Disputes Act,

1947 is dismissed for default against the O.P. company with cost.
