Seen the settlement paper and receipt of cheque of Rs. 11,686.00 by the petitioner from the O.P. company.

Hence, it is

ORDERED

that the Case No. 02 of 2016 under Section 10(1B)(d) of The Industrial Disputes Act,

1947 is disposed of today on consent in terms of the memorandum of settlement dt.

29.08.2022.

Let the memorandum of settlement dt. 29.08.2022 be made a part of this Award.

Let this order and judgement be treated as an Award.
