## Case No. 09/2018

## Under Section 2A(2) of The Industrial Disputes Act, 1947

.....Opposite party

Order No.59 dated: 04.08.2023

Today is fixed for evidence on merit and the Ld. Lawyer for the Opposite Party Company is present but the petitioner and his Advocate are absent and none appears for the petitioner and no step is taken for the petitioner.

Record shows that in 2018 the petitioner has filed this case and the case has been pending for a long time for evidence on merit but the petitioner has not been attending the Tribunal for his evidence and on the last date on 19.07.2023 the Ld. Lawyer for the petitioner submitted that he had no instruction from the petitioner and orally prayed to issue show cause notice to the petitioner and then one more chance was given to the petitioner to appear on 04.08.2023 for evidence on merit but neither the petitioner nor his lawyer appeared on 04.08.2023 for evidence on merit.

Record shows that the petitioner has filed this case praying for reinstatement of his service with full back wages and other consequential benefits and prayed for a declaration that the refusal of employment to the petitioner by way of termination from service on 21.06.2016 is illegal, unjustified, malafide and unfair and then the Opposite Party Company appeared in this case and submitted written statement and then issues were framed and the case was fixed for evidence on merit but the petitioner has not been attending the Tribunal for his evidence on merit in spite of getting many opportunities.

Hence I hold that the petitioner is not interested to proceed with this case.

Hence, it is

## ORDERED

that the Case No.09/2018 under Section 2A(2) of The Industrial Disputes Act, 1947 is dismissed for default against the Opposite Party Company with cost.

Let this order be treated as an Award.

According to Section 17AA of The Industrial Disputes Act, 1947, let a certified copy of this award be sent to the Additional Chief Secretary to the Government of West Bengal, Labour Department, New Secretariat Buildings, 1, K.S.
