AND WHEREAS the workman has filed an application under section 10 of the Industrial Dispute Act, 1947 (14of 1947) to the Ninth Industrial Tribunal specified for this purpose under this Deptt.'s Notification No. 1085-IR/12L-9/95 dated 25.07.1997.

AND WHEREAS, the Ninth Industrial Tribunal heard the parties under section 10 of the I.D. Act, 1947 (14of 1947) and framed the following issue dismissal of the workman as the "issue" of the dispute.

A W A R D

Ld.lawyer for the employer/hospital is present.

Received the report from the Asansol (South) alongwith copy of notice. It transpires from the the concerned workman/employee received notice on 27.11.2023.

Workman/employee fails to appear.

Hd. ld. lawyer for the employer/hospital, who submits that no industrial dispute exists between the parties, and the instant case is disposed of as no dispute award.

RIBUNAL Perused the entire CR as well as the report of the concerned P.S.

Considered.

It transpires from the CR that the Govt. of West Bengal through its Joint Secretary, Labour Deptt. vide reference no. <u>Labr./697/(LC-IR)/</u> 22015(16)/6/2023 dated 08.08.2023 referred the Industrial Disputes between the parties, as mentioned herein above, for adjudication under the Industrial Disputes Act, 1947 (hereinafter referred to as Act of 1947) for adjudication.

The concerned Joint Secretary in exercise of the power conferred by U/S 10 of the Act, 1947 referred the industrial disputes for adjudication after framing the following issues:

1) Whether the refusal of employment of the workman namely Sri Dhannjay Chourashya by the management of M/S. Indra IVF Hospital Pvt.Ltd.3rd floor, Regal Plaza, G.T. Road, Murgasole, Asansol Dist.-Paschim Bardhaman, PIN- 713303 by way of forceful resignation on 03.06.2020 is justified?

To what relief, if any, is he entitled?

After received of the aforementioned reference order this tribunal registered the instant case U/S 10 of the Act of 1947 and put both the parties to notice by speed post and after service of the same although employer/hospital appeared through its ld. Lawyer but the workman/employee failed to appear. Despite of service of notice by speed post upon the workman/employee this tribunal again sent notice to her through the local P.S on the address as mentioned in the reference order of the Govt. of West Bengal, and the concerned P.S submitted a report that the same was received on 27.11.2023.

It is all the more pertinent to mention herein that the said workman approached the labour Commissioner for conciliation of the industrial dispute between him and his said employer and as the same failed, so the Govt. of West Bengal after due consideration of the failure report referred the industrial dispute to this tribunal for adjudication. Thus, the concerned workman certainly had/has all along the knowledge of reference of the impugned case but inspite thereof he showed no interest to appear before this tribunal.

Having regard to the above facts and circumstances I am of the view that workman/employee does not want to proceed further with the instant case and there exists "no industrial disputes" between the above-named workman/employee and M/S Indira IVF Hospital Pvt.Ltd.

Hence, it is,

Ordered

that the reference under Section 10 of the Industrial Disputes Act, 1947, is disposed of as no dispute award between the parties but without cost.

This is my award.
