AND WHEREAS the workman has filed an application under section 10 of the Industrial Dispute Act, 1947 (14of 1947) to the Ninth Industrial Tribunal specified for this purpose under this Deptt.'s Notification No. 1085-IR/12L-9/95 dated 25.07.1997.

# Case No. 35 / 2023 U/S 10 of the Industrial Disputes Act, 1947.

## The award dated 29th day of Nov., 2023.

### A W A R D

Ld.lawyer for the employer/hospital is present.

CR is taken up for passing order.

Perused the entire materials of the CR. Considered.

It transpires from the CR that the Govt. of West Bengal through its Joint Secretary, Labour Deptt. vide reference no. Labr./764/(LC-IR)/ 22015(16)/6/2023 dated 18.08.2023 referred the industrial disputes between the parties, as mentioned herein above, for adjudication under the Industrial Disputes Act, 1947 (hereinafter referred to as Act of 1947) for adjudication.

The concerned Joint Secretary in exercise of the power conferred by U/S 10 of the Act, 1947 referred the industrial disputes for adjudication after framing the following issues:

- DURGAPUR
- Prasad by the management of M/S. Indra IVF Hospital Pvt.Ltd.3rd floor, Regal Plaza, G.T. Road. Murgasola Account floor, Regal Plaza, G.T. Road. Murgasola Bardhaman, PIN-713303 by way of forceful resignation on 03.06.2020 is justified?
  - 2) To what relief, if any, is the entitled?

After received of the aforementioned reference order this tribunal registered the instant case U/S 10 of the Act of 1947 and put both the parties to notice by speed post and in consequence thereof although employer/hospital

appeared through its ld. Lawyer but the concerned employee/workman failed to appear till this date.

CR further reveals that initially the notice was sent by speed post but the same returned unserved with an endorsement of "Left" of the concerned Postman and thereafter this tribunal sent notice to her through the local P.S in the same address, as mentioned in the reference order of the Govt. of West Bengal, and the same was received by the employee/workman on 06.11.2023. Despite of such service she failed to appear in this case till this date.

It is all the more pertinent to mention herein that the said workman/employee approached the labour Commissioner for conciliation of the industrial dispute between her and her said employer and as the conciliation proceeding failed, so the Govt. of West Bengal after due consideration of the failure report referred the industrial dispute to this tribunal for adjudication after notice to both the parties. Therefore, the concerned employee /workman certainly has/had the knowledge of reference of the impugned case.

Having regard to the above facts and circumstances I am of the view that employee/workman does not want to proceed further with the instant case and "no industrial disputes" between the there exists employee/workman and M/S Indira IVF Hospital Pvt. Ltd.

Hence, it is,

### Ordered

that the reference under Section 10 of the Industrial Disputes Act, 1947, is disposed of as no dispute award between the parties but without cost.

This is my award.
