**Today is fixed for passing order in respect of Memorandum of Settlement
on compromise dated 28.08.2024 , filed by both the parties.**

The case record is taken up for passing order.

**Perused the Memorandum of Settlement (Exbt. B) dated 28.08.2024, joint
petition filed by the parties and petition under Section 10(1B)(d) of the
Industrial Disputes Act, 1947 (as amended) as well as evidence of the applicant
Sri Anik As (P.W.1) and Mr. Koustubh Pradhan, Lead - Employee Relations &
Compliances , authorized representative of the Company namely M/s. Sanofi
India Ltd., (O.P.W.1), the Power of Attorney enclosed (Exbt. A) , so adduced in
support of said Memorandum of Settlement (Exbt. B) . It appears from the
evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been
settled in between the parties in terms of Memorandum of Settlement dated
28.08.2024 (Exbt. B) . I further find from the said joint petition , Memorandum
of Settlement as well as from the evidence of both parties that the Company has
handed over a demand draft being No. 778548 dated 02.09.2024 of Rs.
6,26,297/- (Six lakh twenty six thousand two hundred ninety seven) only drawn**

on HDFC Bank Ltd., to the applicant as full and final settlement amount and the applicant has issued a receipt of the same, marked as Exbt. B and the said demand draft was handed over to the applicant as full and final settled amount and the applicant (P.W.1) has no grievance against the O.P./Company at present. A xerox copy of the said Demand Draft of full and final settled amount was marked as Exbt. 1. An original money receipt has been filed to that effect . Considered.

The Memorandum of Settlement dated 28.08.2024 and the joint petition dated 29.08.2024 filed by the parties has duly been signed by the applicant, Sri Sri Anik As (P.W.1) and Mr. Koustubh Pradhan (O.P.W.1) representing the O.P./Company voluntarily. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise , which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

that the settlement between the parties is allowed and accordingly, the proceedings under Section 10(1B)(d) of the Industrial Disputes Act, 1947, as amended , be and the same is disposed of in terms of the Memorandum of Settlement dated 28.08.2024. The Memorandum of Settlement dated 28.08.2024 is made part of the Award.


