# AWARD

Applicant Tanumay Roy is absent without steps.

O.P. /Company is absent.

Today is fixed for passing no dispute award.

Case record is taken up for passing no dispute award.

This case has been filed by the applicant/workman Tanumay Roy under Section 2A(2) of the Industrial Disputes Act, 1947 against his employer M/s. K.N.D. Engineering Technologies Limited in connection with termination of his service by way of refusal of employment illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that as the applicant is not appearing before this Tribunal since 14.09.2021. In view of order dated 09.06.2022 notice was issued upon the applicant asking him to appear personally before this Tribunal on 27.07.2022 and file show cause as to why no dispute award shall not be passed in the instant case. Thereafter, fresh notice was issued upon the applicant on 12.06.2023 asking him to appear

before this Tribunal on 04.08.2023 and file show cause as to why no dispute award should not be passed in the instant case. Thereafter, further notice was sent to the applicant in view of the order dated 26.09.2023 fixing 07.11.2023 for appearance and filing show cause as to why no dispute award shall not be passed in the instant case. Again a further notice was sent to the applicant on 07.11.2023 fixing 27.12.2023 for appearance and filing show cause as to why no dispute award shall not be passed in the instant case. On 27.12.2023 though the applicant was not present, but his Ld. Advocate was present and submitted that the case/dispute has been settled between the parties and prayed to pass no dispute award.

Considering the conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

# Ordered

that the case being No. 31 of 2018 u/S 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
