# **AWARD**

### Dated :27-02-2025

The Labour Department, Government of West Bengal has referred an Industrial Dispute between M/s. Indotan Chemicals Limited, Vill.-Garji, P.O.-Bighati, Dist.-Hooghly, Pin-712124 and its workman Sri Bishnudev Mahato, Vill.-Garji, P.O.-Bighati, Dist.-Hooghly, Pin-712124 to this Tribunal vide Order No. 221/(LC-IR)/22015(16)/14/2023 dated 23.03.2023 on the following issue(s) for adjudication:

#### **ISSUES**

- 1) Whether the refusal of employment of the workman Shri Bishnudev Mahato by the management of M/s. Indotan Chemicals Limited w.e.f. 01.04.2021 is justified?
- 2) To what relief, if any, is the workman entitled?

On receiving the 'Order of Reference' of the appropriate Government containing 'Reference of Disputes', this Tribunal on 29.03.2023 by its Order No. 1 issued Notice upon both the parties. On receiving the notice, M/s. Indotan Chemicals Limited entered its appearance through its Ld. Advocate duly appointed by executing Vakalatnama. The workman Bishnudev Mahato entered his appearance by filing Vakalatnama authorizing Ld. Advocate Debasish Sengupta to represent him in this case.

The record shows that on 26.07.2023 Ld. Advocate for M/s. Indotan Chemicals Limited submitted that there was a fair chance of settlement of the dispute. Ld. Advocate for the workman did not raise objection against such submission of the Ld. Advocate for M/s. Indotan Chemicals Limited. Subsequently, Ld. Advocates for the both sides submitted joint petition with the prayer for time to file Memorandum of Settlement. It is seen that Ld. Advocates for both the parties on consecutive dates sought adjournments on the plea that Memorandum of Settlement would be filed but ultimately the parties to this case have failed to file any Memorandum of Settlement. It is to note here that neither M/s. Indotan Chemicals Limited nor the workman Bishnudev Mahato has filed respective written statement in this case till today. The fact remains that this Tribunal has given adjournments on series of dates being led by the joint submission that Memorandum of Settlement would be filed by the parties for amicable settlement of this instant industrial dispute, but ultimately it is transpired that the parties to this case have failed to file any Memorandum of Settlement. Moreover, the parties to this case did not file their Written Statements.

On scrutiny of the record it is found that this Tribunal by its order dated 25.11.2024 directed the workman Bishnudev Mahato to show-cause as to why the instant industrial dispute would not be disposed of by passing a No Dispute Award. This

Tribunal passed the order dated 25.11.2024 with the observation that the parties to this case might not be able to reach an agreement for the amicable settlement of the industrial dispute. It was also observed that the workman Bishnudev Mahato remained absent before this Tribunal persistently and continuously. It is seen that although this Tribunal by order dated 25.11.2024 directed the workman to submit show-cause but the workman did not comply the order of this Tribunal.

It is seen that today neither the workman nor his Ld. Advocate is found present before this Tribunal. As well as Ld. Advocate for M/s. Indotan Chemicals Limited is found absent.

In view of the situation and non-complying conduct/attitude of the workman, this Tribunal thinks it fit and proper to pass a No Dispute Award today.

The conduct of the workman, as discussed above, indicates that perhaps he has lost his interest in this case and also he has abandoned the matter in dispute i.e. the industrial dispute between him and the Company and thus this is a fit case to be dealt with as per Rule 22 of the West Bengal Industrial Dispute Rules, 1958 since the industrial dispute is ceased to be existed.

Accordingly, and in terms of Rule 22 of the West Bengal Industrial Disputes Rules, 1958 as amended till date, this Tribunal holds that the instant **Industrial Dispute** being Case No. 07/2023/10 instituted on 29.03.2023 is no longer in existence, between the parties.

The aforesaid constitutes the **No Dispute Award** passed by this Tribunal in the instant Case No.07/2023/10, which stands disposed of forthwith.
