# The Award dated the 05th February, 2025

The C.R is taken up today for passing necessary order as the workman failed to take step and submit the fresh address of the employer for causing service of notice upon him on number of occasions.

Perused the C.R and considered. It is transpired from the C.R that the Govt. of West Bengal through its Asstt. Secretary, Labour Department vide Ref. No. Labr./172/(LC-IR)/22015(16)/13/2024 dated 19.02.2024 referred the Industrial Disputes between the parties as mentioned herein above, for adjudication under the Industrial Disputes Act,1947 (hereinafter referred to as Act of 1947) for adjudication.

The Asstt. Secretary in exercise of the power conferred U/S 10 of the Act, 1947 referred the industrial disputes for adjudication after framing the certain issues mentioned herein below:

- 1) Whether the refusal of employment of the workman namely, Sri Amit Kumar Bouri by the management of M/S G.P. Mukherjee & Co., Chinnamasta, Burnpur Road, Asansol, Dist.- Paschim Bardhaman, PIN-713325on 16.05.2022 is justified?
- 2) To what relief, if any, is he entitled?

After receipt of the aforementioned reference order this tribunal was pleased to register the instant case U/S 10 of the Act, 1947 and issued notice to both the parties.

It is evident from the order no. 2 dated 14.03.2024 passed by this Industrial Tribunal, I find that pursuant to the notice issued by this tribunal the workman Sri Amit Kumar Bouri appeared before this Industrial Tribunal alongwith Vokalatnama of his ld. lawyer Mr. Subrata Jana with a prayer for time for filing the written statement on the ground stated in his application. But the notice was not served to the employer M/S G.P. Mukherjee & Co., Chinnamasta, Burnpur Road, Asansol, Dist.- Paschim Bardhaman, PIN-713325 with an endorsement of the postal staff that the same could not be located. Accordingly, fresh notice was issued upon the employer as per the address furnished by the workman and the next date was fixed on 27.03.2024 for A/D of notice of the employer and appearance of workman. It is also transpired from order no. 3 dated 27.03.2024 passed by this Industrial Tribunal that workman was absent without any step. Notice was issued upon the employer but the same was returned un-served with postal remark 'insufficient address'. Accordingly, a fresh notice was further issued upon the employer at once and the case was further fixed for A/D of employer and appearance of workman on 16.04.2024. It is also found from order no.5 dated 29.10.2024 that none appears on behalf of both the parties and no step was taken on call. It is also found in the said order that notice was issued upon the O.P/employer but the same was returned and un-served with postal remark 'insufficient address' could not be located.

Sd/ Judge The petitioner/workman was further directed to file fresh address of the O.P/employer for issuance of notice and the case was further fixed on 25.11.2024 for taking steps by the workman.

It is also apparent from order no.6 dated 25.11.2024 that none appears on behalf of both the parties and no step was taken on call. It was at 1.25 p.m. However, for the ends of justice, another opportunity was given to the workman for taking step and the case was further fixed on 10.12.2024 for taking step by the workman as a last chance.

It is evident from order no.7 dated 10.12.2024 that the workman files hazira but no fresh address of the employer was filed on that day before this Tribunal. Consequently, another opportunity was given to the workman as special chance and the case was fixed on 09.01.2025 for filing fresh address of the employer/O.P. by the workman as special chance in default necessary order shall be passed.

It is also evident from order no. 8 dated 29.01.2025 // 13.01.2025 that P.O was on leave on 09.01.2025 and the C.R was put up for order on 13.01.2025 fixed on 29.01.2025 for filing fresh address of the employer/O.P by the workman as special chance in default necessary order shall be passed.

It is also evident from order no.09 dated 29.01.2025that both the parties were absent without any step and it was now at 1.10 p.m. Both the parties were not interested to proceed with this case. So, an appropriate award may be passed.

Having regard to the above facts and circumstances of this case, I am of the considered view that the workman does not want to proceed further of the instant case as he has failed to supply the proper address of his employer for causing the service notice upon him on a number of occasions. Therefore, it is held that there exists no industrial disputes in between the above named workman and M/S G.P. Mukherjee & Co.

### Ordered

that the reference Under Section 10 of the Industrial Disputes Act, 1947 is disposed of as no dispute award between parties but without cost.
