A W A R D

This Award delivered on Thursday, the 26th Day of December, 2024

Today is fixed for passing order in respect of Memorandum of Settlement on compromise dated 10.12.2024 and joint petition filed by both the parties.

The case record is taken up for passing order.

Perused the Memorandum of Settlement (Exbt. B) dated 10.12.2024, joint petition filed by the parties under Section 2A(2) of the Industrial Disputes Act, 1947 (as amended) as well as evidence of the applicant Shri Raj Kumar Rajak (P.W.1) and Shri Himadri Bora, Branch Manager of Guwahati and Kolkata Branch of M/s. Omega Elevators, (O.P.W.1), the xerox copy of the identity card of the O.P.W.1 issued by the O.P./Company (Exbt. A), a xerox copy of the demand draft (Exbt. 1), so adduced in support of said Memorandum of Settlement (Exbt. B).

It appears from the evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 10.12.2024 (Exbt. B). I further find from the said joint petition, Memorandum of Settlement as well as from the evidence of both parties that the Company has handed over a demand draft being No. 703154 dated 13.12.2024 of Rs. 2,00,000/- (Two lakh) only drawn on Kotak Mahindra Bank, Ahmedabad to the applicant as full and final compensation amount and the applicant has been reinstated in the O.P./Company on 11.12.2024 with continuity of his service without any break.

It also appears from the Exbt. B that the P.F. and other statutory benefits of the applicant/workman shall be regularized by the O.P./Company and the applicant/workman has no grievance against the O.P./Company at present.

Considered.

The Memorandum of Settlement dated 10.12.2024 and the joint petition dated 10.12.2024 filed by both the parties has duly been signed by the applicant, Shri Raj Kumar Rajak (P.W.1) and Shri Himadri Bora (O.P.W.1) representing the O.P./Company voluntarily. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise, which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

Hence, it is

Ordered

that the settlement between the parties is allowed and accordingly, the proceedings under Section 2A(2) of the Industrial Disputes Act, 1947, as amended, be and the same is disposed of in terms of the Memorandum of Settlement dated 10.12.2024. The Memorandum of Settlement dated 26.09.2024 is made part of the Award.

This is my Award.
