Both the parties are absent without steps.

Today is fixed for passing no dispute award in view of order no. 35 dt. 10.12.2024.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Sri Prasenjit Ghosh under Section 2A(2) of the Industrial Disputes Act, 1947 against his employer M/s Cardila Pharmaceutical Ltd in connection with termination of service of the applicant illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that since 22.02.2024 the applicant is absent and on 03.06.2024 a show cause notice was issued upon him directing to file reply to show cause on 16.07.2024 as to why no dispute award shall not be passed in the instant case.

On 16.07.2024 it appears from the record that one envelope containing notice sent to the applicant is received back with the postal remark "Insufficient address" and accordingly, a fresh notice was issued upon the applicant directing him to appear on 28.08.2024 and file reply to show cause as to why no dispute award shall not be passed in the instant case. On 28.08.2024 it appears from the postal track report that the notice sent to the applicant was delivered and the applicant was absent on that day also on repeated calls. Therefore, it appears that the applicant is not interested to proceed with his present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds

that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

# Ordered

that the case being No. 01 of 2020 u/S 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.

This is my award.
