## <u>AWARD</u>

This Award delivered on Thursday the 13th Day of March, 2025.

Today is fixed for passing order in respect of Memorandum of Settlement on compromise dated 06.03.2025 and joint petition dated 24.02.2025 filed by both the parties.

The case record is taken up for passing order.

At the very outset, the Ld. Advocates for the parties apprises this Tribunal that the applicant has been reinstated in the O.P/ club on and  $\frac{07}{03}$ ?

Heard both the parties.

Perused the Memorandum of Settlement (Exbt. 1) dated 06.03.2025, joint petition praying for passing award in terms of the memorandum of settlement filed by the parties as well as evidence of the applicant Shri Dibakar Mondal (P.W.1) and Kumar Chandra Bhusan, authorized person on behalf of the Secretary of the O.P., Cossipore Club, (O.P.W.1), the authority letter of the O.P.W.1 issued by the O.P./Club (Exbt. A), two xerox copies of cheques (Exbt. 2 & 2/1) and the receipt of the same Exbts B & B/1, so adduced in support of said Memorandum of Settlement(Exbt. 1).

It appears from the evidence of P.W.1 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 06.03.2025 (Exbt. 1).

It further appears from the said joint petition, Memorandum of Settlement as well as from the evidence of both parties that the O.P./Club has handed over Rs. 1,80,000/-as lumpsum amount as full and final compensation amount by way of cheque being No. 039188 dated 24.02.2025 and also Rs. 21,600/- on account of the employer's contribution of provident fund by way of Cheque being No. 039197 dated 06.03.2025 drawn on SBI, Northern Avenue Branch to the applicant drawn on SBI, Northern Avenue Branch to the applicant and also that the O.P/Company will reinstate the applicant on and from 07.03.2025 with continuity of the service of the applicant without any break. The Ld. Advocates for the parties appraises today to this Tribunal that the applicant has been reinstated in the O.P/Club on 07.03.2025 with continuity of his service without any break.

It also appears from the Exbt. 1 that the P.F. and other statutory benefits of the applicant/workman shall be regularized by the O.P./Company and the applicant/workman has no grievance against the O.P./Club at present.

Considered.

The Memorandum of Settlement dated 06.03.2025 and the joint petition dated 24.02.2025 filed by both the parties has duly been signed voluntarily by the applicant, Shri Dibakar Mondal (P.W.1) and signed voluntarily by Kumar Chandra Bhusan (O.P.W.1) representing the O.P./Club. Since the matter has already been settled between the parties to the proceedings, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise, which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

Hence, it is

#### Ordered

that the settlement between the parties is allowed and accordingly, the proceedings of the instant case No. 53/2022 under Section 10(1B)(d) of the Industrial Disputes Act, 1947, as amended , be and the same is disposed of in terms of the Memorandum of Settlement dated 06.03.2025. The Memorandum of Settlement dated 06.03.2025 is made part of the Award.

This is my Award.

Let the copies of the Award be sent to the appropriate authority for information and taking necessary action.
