Applicant Mrs. Gopa Banerjee is absent without steps.

Today is fixed for passing no dispute order in view of order no. 48 dated 08.02.2024.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Mrs. Gopa Banerjee under Section 2A(2) of the Industrial Disputes Act, 1947 against opposite party in connection with termination of his service with effect from 02.12.2016 illegally with a prayer to reinstate her in service with full back wages and other consequential benefits and also costs and interests thereto.

Perused the case record wherefrom it appears that on 11.04.2023 order was passed fixing 09.06.2023 for filing show cause by the applicant/workman for her non appearance, but no show cause was filed by the applicant/workman. On 07.12.2023 the Tribunal again issued notice to the applicant directing her to appear on 15.01.2024 and file show cause as to why no dispute award shall not be passed in the instant case. On the said date Ld. Advocate for the O.P. was present and filed postal track report in connection with the notice sent to the applicant. It appeared from the said postal track report that the notice sent to the applicant was delivered with the postal remark 'Item delivered (Addressee)', but the applicant neither appeared nor filed any show cause from her side. Thereafter, an opportunity was given to the applicant vide order no. 47 dated 15.01.2024 fixing 08.02.2024 for

appearance and filing show cause in default necessary order shall be passed.

On 08.02.2024 the applicant was absent on repeated calls and no show cause has been filed from the side of the applicant despite due service of notice upon the applicant. So, considering the conduct of the applicant, it appeared that the applicant did not think it necessary to appear before this Tribunal till date and also did not think it necessary to file show cause in view of order no. 46 dated 07.12.2023. Therefore, it is clear that the applicant is not willing to proceed with his present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

Ordered

that the case being No. 11 of 2017 U/s 2A(2) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award '.
