Applicant Prem Ratan Raj Karanikar is absent without steps.

O.P. /Company is absent.

Today is fixed for passing no dispute award in view of order no. 58 dt. 08.11.2023.

Case record is taken up for passing order.

This case has been filed by the applicant/workman Prem Ratan Raj Karanikar under Section 10(1B)(d) of the Industrial Disputes Act, 1947 against his employer M/s. Dr. Subhas Kumar Ghosh in connection with termination of his service by way of refusal of employment illegally with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that two persons namely Smt. Sonali Ghosh and Smt. Sayani Ghosh has been added as Opposite Parties No. 2 and 3 respectively vide order no. 31 dated 07.02.2020. Thereafter, on 09.03.2021 the O.P. No. 1 was expunged from the cause title as Dr. Subhas Kumar Ghosh expired on 15.12.2018 and accordingly, the above two persons namely Smt. Sonali Ghosh and Smt. Sayani Ghosh has been renumbered as Opposite Parties No. 1 and 2 respectively. Since 31.03.2021

the applicant was absent, a notice was issued on 30.11.2021 upon him directing to file show cause on 11.01.2022 as to why no dispute award shall not be passed in the instant case. Till 24.07.2023 the applicant was absent on repeated calls. Thereafter, vide order no. 57 dated 19.09.2023 a fresh notice was sent to the applicant directing him to file show cause on 08.11.2023 as to why no dispute award shall not be passed in the instant case. On 08.11.2023 the applicant was absent on repeated calls.

Thereafter, a further notice was issued and sent to the applicant directing him to appear before this Tribunal on 18.12.2023 and file show cause as to why no dispute award shall not be passed in the instant case. On 18.12.2023 the applicant was also absent on repeated calls. Vide Order No. 59 dated 18.12.2023 the case was fixed for passing no dispute award on the next date i.e. 28.12.2023.

Despite service of notice upon the applicant, he did not bother to appear before this Tribunal till date and no show cause was also filed from the side of the applicant till date. Therefore, it is clear from the conduct of the applicant that he is not willing and bothered to proceed with his present case further.

In view of the aforesaid conduct of the applicant, this Tribunal holds that no industrial disputes exist in between the parties. So, I am inclined to pass a 'No Dispute' Award on the footings that Industrial Disputes under Rule 22 under West Bengal Industrial Dispute Rules, 1958 is no longer in existence.

Hence, it is

#### Ordered

that the case being No. 04 of 2017 u/S 10(1B)(d) of the Industrial Disputes Act, 1947 be and the same is dismissed for non existence of any Industrial Dispute. This is to be treated as 'No Dispute Award'.
