AWARD

This Award is delivered on Tuesday, the 30th Day of April, 2025.

Today is fixed for passing order in respect of Memorandum of Settlement on compromise dated 22.04.2025, filed jointly by the parties.

The case record is taken up for passing order.

Perused the Memorandum of Settlement dated 22.04.2025, joint petition filed by the parties under Section 2A(2) of the Industrial Disputes Act, 1947 (as amended) as well as evidence of the applicants namely (1) Sri Rajesh Yadav (P.W.1), (2) Md. Wasim (P.W.2) and (3) Meher Hossain (P.W.3) and Mr. Sailendra Nath Rakshit, the Manager of the O.P./Company namely M/s Antarctica Limited (O.P.W.1) letter of authorization (Exbt. A), so adduced in support of said Memorandum of Settlement(Exbt.B).

It appears from the evidence of P.W.1, P.W.2, P.W.3 and O.P.W.1 that the matter in dispute has already been settled in between the parties in terms of Memorandum of Settlement dated 22.04.2025 (Exbt. B). I further find from the said joint petition, Memorandum of Settlement as well as from the evidence of the parties that the Company has handed over the cheques being Nos. 824540 dated 11.03.2025 of Rs. 18,500/- (Eighteen thousand five hundred), 824541 dated 26.03.2025 of Rs. 18,500/- (Eighteen thousand five hundred) and 824542

dated 10.04.2025 of Rs. 18,350/- (Eighteen thousand three hundred fifty) to Shri Rajesh Yadav, the cheques being Nos. 824539 dated 11.03.2025 of Rs. 5,300/- (Five thousand three hundred), 824538 dated 26.03.2025 of Rs. 5,300/- (Five thousand three hundred), 824537 dated 10.04.2025 of Rs. 5,092/- (Five thousand ninety two) to Md. Wasim and the cheques being Nos. 824543 dated 11.03.2025 of Rs. 9,000/- (Nine thousand), 824544 dated 26.03.2025 of Rs. 9,000/- (Nine thousand) and 824545 dated 10.04.2025 of Rs. 7000/- (Seven thousand) only drawn on Punjab National Bank, Old Court House Street, Kolkata – 700 001 to Meher Hossain as full and final settlement amount as per Memorandum of Settlement. The xerox copies of the said cheques were marked as Exbt. 1, 1/1/1/2, 2, 2/1, 2/2, 3, 3/1, 3/2 . Considered.

The Memorandum of Settlement dated 22.04.2025 and the joint petition dated 24.04.2025 filed by both the parties has duly been signed voluntarily by the applicants, Rajesh Yadav (P.W.1), Md. Wasim (P.W.2), Meher Hossain (P.W.3) and Mr. Sailendra Nath Rakshit (O.P.W.1) authorized representative of the O.P. (Manager of the Company). Since the matter has already been settled between the parties to the proceedings/case, I am of the view that this Tribunal should not stand in the way of their such settlement/compromise, which appears to be legal and valid, and so, this Tribunal finds no impediment in allowing such prayer made jointly by the parties voluntarily.

Hence, it is

Ordered

that the settlement between the parties is allowed and accordingly, the proceedings of the instant case being No. 48/2017 under Section 2A(2) of the Industrial Disputes Act, 1947, as amended , be and the same is disposed of in terms of the Memorandum of Settlement dated 22.04.2025. The Memorandum of Settlement dated 22.04.2025 is made part of the Award.

This is my Award.
