Indoco Remedies Ltd in connection with illegal termination of his service vide letter dated 16.01.2018 issued by the O.P. with a prayer to reinstate him in service with full back wages and other consequential benefits.

Perused the case record wherefrom it appears that order was passed on 07.04.2022 fixing 25.05.2022 for further cross-examination of O.P.W.1, but on 25.05.2022 both the parties were absent without any steps and accordingly, show cause notice was issued upon the applicant directing him to appear before this Tribunal on 18.07.2022. It appears from the order dated 28.11.2023 that the notice sent to the applicant is received back with

Thereafter, a further fresh notice was issued on 26.12.2023 directing the applicant to appear and file reply to show cause on 15.02.2024 as to why no dispute award shall not be passed in the instant case. Again on 04.09.2024 a fresh notice was issued upon the applicant directing the applicant to appear and file reply to show cause on 04.09.2024 as to why no dispute award shall not be passed in the instant case. It further appears from the order dated 17.02.2025 that the notice sent to the applicant was delivered with the postal remark "Item Delivered (Addressee)", but on that date, the applicant was found absent on repeated calls.
