Howrah - 711302 and its workman Shri Saptadip Kundu, S/o Shri Raj Kumar Kundu, Raj Mahal Road, Maheshmati, P.S.- English Bazar, Dist.- Malda, Pin - 732101 regarding the issues being a matter specified in the second schedule of the Industrial Dispute act, 1947 (14of 1947);

AND WHEREAS the workman has filed an application directly under sub-section 2 of Section 2A of the Industrial Dispute act, 1947 (14of 1947) to the Second Industrial Tribunal specified for this purpose under this Department Notification No. 101- IR dated 2.2.12;

The Ld. Lawyer of the O.P. Company appears today.

The Petitioner is absent but his Ld. Lawyer is present.

Today is fixed for filing amendment petition by the petitioner.

The Ld. Lawyer for the petitioner submits that the petitioner is not interested to proceed further with this case and for this reason the Ld. Lawyer will not take any steps today and prayed for necessary order.

Heard both sides and perused the record.

On perusing the record I find that on 01.12.2021 the petitioner Sri Saptadip Kundu, son of Sri Raj Kumar Kundu, Raj Mahal Road, Maheshmati, P.S. English Bazar, Distt.-Malda, Pin-732101 has filed the Case No.17/2021 Under Section 2A(2) of the Industrial Disputes Act, 1947 against The M/S Himalaya Wellness Company, C/O. Sinha Coal Storage, Alampur, National Highway-6, Near Indian Oil Petrol Pump, Howrah-711302 praying for reinstatement of his service in the opposite party company by setting aside the order of illegal retrenchment and full back wages alongwith other consequential service benefits, and then the O.P. Company appeared in this case and filed written statement and then the case was pending for a long time for filing the amendment petition by the petitioner as per his prayer and today also the date was fixed for filing the said amendment petition but today the Ld. Lawyer for the petitioner submits that he has no instruction from his client and he prayed for necessary order.

So the above circumstances clearly prove that though the Petitioner has filed this case in 2021, he has not been appearing for further proceedings of this case. On the contrary, the O.P. Company has been attending the Tribunal for contesting this case.

As the Petitioner is not interested to proceed with this case further and he has not been attending this Tribunal as per submission of his lawyer, I hold that there is no legal necessity to proceed with this case.

Hence, it is

ORDERED

that the Case No.17/2021 Under Section 2A(2) of The Industrial Disputes Act 1947 is dismissed for default against the O.P. Company without cost as the industrial dispute is no longer in existence.

Let this judgement and order be treated as an Award.

According to Section 17AA of The Industrial Disputes Act, 1947, let a certified copy of this award be sent to the Principal Secretary to the Government of West Bengal, Labour Department, New Secretariat Buildings, 1, K.S. Roy Road, Kolkata 700 001 for information, and let a certified copy of this award be supplied to each of both the parties of this case, free of cost, forthwith for information.

The case is disposed of today.
