Permanent Sangrami Sramik Union (Regd. No. 28617) Kalatalahat, Ramnagar, South 24 Parganas, Pin - 743504 Vide G. O. No. Labr./975/(LC-IR)22015(16)/665/2019 dated 20.11.2019 and reference no. 3115-IR/IR/3A-6/59, dated 21/06/1960 referred to this Tribunal for adjudication on the following issues:-

ISSUE(S)

- 1. Whether temporary suspension of work in M/s. Pacific Cotspin Limited. w.e.f. 12.08.2016 by the management is justified?
- 2. What relief(s), if any, workmen are entitled to?

The case record is taken up for passing order.

Perused the case record wherefrom it appears that 11.06.2024 was fixed for hearing the petition dated 22.06.2024 filed by the Ld. Advocate for the company where he prayed to stay the instant proceedings till completion of the corporate insolvency resolution which was still in process in N.C.L.T. and objection if in the mean time. At this stage Ld. Advocate for the workmen files objection petition along with order copy of N.C.L.T.

After that 27.06.2024 was fixed for filing the current status of N.C.L.T. by the Company and also hearing petition dated 11.06.2022.

Accordingly, the order dated 27.06.2024 is as follows:-

"Today is fixed for filing the current status of NCLT by the Company and also hearing petition dated 11.06.2022.

Both the Ld. Advocates are present.

Westrial

Today the Ld. Advocate appearing on behalf of the Company has filed a judgement passed by the NCLT, Kolkata Branch, Court No. 2, Kolkata in respect of the above Company.

The Ld. Advocate further draws my attention to the letter dated 17.06.2022 addressed to the Judge-in-charge, Industrial Tribunals by C.A. Perveen Bansal, Insolvency Professional. Registered Valuer, Chartered Accountant and submits that the above Company i.e. Pacific Cotspin Ltd. has already gone to liquidation and Mr. Perveen Bansal has been appointed as

sinterim resolution professional and moratorium and prays for passing necessary order.

The Ld. Advocate appearing on behalf of the workman candidly submits that this Court has got no jurisdiction to proceed with the case further because the Company has already gone to liquidation and liquidator has already been appointed and the workmen may kindly be given a liberty to file appropriate application before the liquidator.

The Ld. Advocate appearing on behalf of the Company raised no objection rather he supported the submission advanced by the Ld. Advocate for the workmen.

Having heard submission of both sides and in view of the judgement passed by the NCLT dated 25.01.2024 and also the letter dated 14.06.2024 sent by Perveen Bansal, this Court has got no jurisdiction to draw the case further.

Hence.

The case is dropped with a liberty to the workman to file appropriate application before the official liquidator."
